## INTRODUCTION

As one of the key stakeholders in the ASEAN Community, cities, local governments and their leaders play a vital role in building an inclusive, forward-looking community and meeting Sustainable Development Goals (SDGs). However, mayors and local leaders cannot thrive with visions confined within their organisations' walls, even though they have many resources and talents to tackle various challenges. This is because the complexity and interconnectedness of challenges in the cities and local governments are too large and complicated to be solved by the leader alone, particularly in the emerging ASEAN region. Therefore, the complexity can only be addressed effectively if the cities, local governments, and other stakeholders collaborate and make alliances to achieve more significant results and face societal challenges. Establishing a platform that can address this collaboration issue is highly needed and anticipated. This is why ASEAN Mayors Forum (AMF) was formed and comes to empower collaboration among mayors, local government leaders and other stakeholders through various activities such as advocacy, capacity building, and knowledge management in the wider ASEAN region.

Since its initial establishment in 2011, the AMF has been promoting sustainable peace, constructive co-operations, enhancing friendly relations, and providing a common ground for sustainable development of all ASEAN cities and people in the area of economic and social, scientific, and technological fields. Besides promoting cross-sector collaboration, AMF has also published declarations since the first ASEAN Mayors Forum in 2011. Furthermore, the AMF has already been endorsing local governments' responsibilities and contributions to ASEAN development remarked by the UN SDGs, the New Urban Agenda (NUA), the Paris Agreement on Climate Change, and the Sendai Framework for Disaster Risk Reduction (SFDRR).

The ASEAN Mayors Forum has the foresight to allow the provincial, city and municipal leaders to establish a platform that is geared towards accelerating the sub-regional integration process in the region. In addition, as a chair, Brunei continues to work to combat poverty in all its aspects, and provided a critical connection between the ASEAN Economic Community and the ASEAN Socio-Cultural Community by framing ASEAN's perspective and goals on circular economy.



Brunei Darussalam has dedicated to enhancing the food system by speeding agricultural and fisheries sector supply, boosting domestic and Foreign Direct Investment (FDI), and increasing the production of safe, Halal, and high-quality food while also strengthening the food system's value chain.





ASEAN Community has been working together to help people overcome the impact of the COVID-19 pandemic. The role of local leaders has been extremely vital in determining how well cities have responded since the start of the outbreak. In addition to physical well-being, healthy mental well-being is crucial for obtaining comprehensive well-being.

# ASEAN MAYORS FORUM: STRENGTHENING COMMITMENT FOR SUSTAINABLE URBANISATION AND ENABLING ENVIRONMENT OF CLIMATE RESILIENCE

Fostering regional cooperation amongst cities and local governments, the ASEAN Sustainable Urbanisation Strategy (ASUS) is in the service of effective coordination for creating an enabling environment in the event. As a regional platform, the forum anticipates climate governance to conduct policy mapping by identifying main climate priorities and strategies for the Urban Act Initiative facilitated by the UCLG ASPAC as the ASEAN Mayors Forum Secretariat.

Funded by BMU Germany for the Urban Act Project preparation, the UCLG ASPAC in partnership with the UNESCAP and the GIZ Bangkok attempts to accomplish regional network engagement by organising a virtual ASEAN Mayors Forum Special Event (plus China and India) on 29 and 30 June 2021.



Taking place in the capital city of Indonesia, the Governor of Jakarta, Mr. Anies Rasyid Baswedan, Ph.D., welcomed the panellists and the participants. There were four sessions held throughout a two day AMF Special Event. The first three sessions emerged to call forth the issue of climate sensitive urban development.

During the Plenary Session, a small group of panellists had their solidarity arrived at a better enabling environment for cities to conduct climate action, such as capacity building for local governments.



The theme "Enabling Environment on Climate Resilience: Local Governments and Cities Commitment to Tackle Climate Change", the ASEAN Mayors Forum provides a plenary session, and is followed by other sessions with various topics of discussion. The overarching objectives are to

(1) reinforce commitments among mayors, political partners and stakeholders and stimulate coordination; (2) promote race to zero and race to resilient campaign among ASEAN Cities and Local Governments networks; and (3) share knowledge on the climate action local practices and urban climate sensitive development plan.

Ms. Armida Alisjahbana, the Executive Secretary of the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), stated that South-east Asia is a vulnerable country to climate change. "The Paris Agreement requires action across levels of government. As local communities and the national government develop Covid-19 recovery strategies, it is time to accelerate this action to be more resilient and greener. No local or national government should act alone, vertical integration of policies is critical. The role of cities must be well defined."

In responding to the COP 26, the UCLG ASPAC, AMF, the Global Covenant of Mayors Secretariat for Southeast Asia (GCoM SEA) and the GCoM Global Regional Coherence (GRC), have successfully organised the ASEAN City Leaders Dialogue under the framework of ASEAN Mayors Forum (AMF), on Monday, January 17<sup>th</sup>, 2022. This event was held back-to-back with the GCoM National Webinars in Southeast Asian countries, which took place before the ASEAN City Leaders Dialogue. The dialogue was a very functional platform for city leaders to express their expertise and experience on climate action and ambition to raise climate awareness and provide guidance to local/regional governments on the outcomes of COP26.



with the concept of back-to-back events, the events have successfully brought together more than 100 participants and speakers from UCLG, GCoM Global, UNFCCC, and other COP26 participants, who shared significant findings and recommendations for future climate actions and implementation. Besides, Governors/Mayors/Regents/City Leaders, local government officials, and representatives of local government groups from Southeast Asia also attended this event. In addition, the ASEAN Secretariat, GCoM Global and Regional Asia Pacific officials and partners, Donors, and National Government representatives were among the other attendees as well.

Continuing the Welcome Remarks, it went to the main session, which was the dialogue of the city leaders from ASEAN countries. Opening the dialogue, Datuk Seri Mahadi Che Ngah, Mayor of Kuala Lumpur, said that Kuala Lumpur has an initiative and programmes to be implemented in line with reducing 70% carbon emission by 2030 and achieving carbon neutrality by the year 2050. Along with that, Kuala Lumpur has maintained the green initiative and identified the climate actions plan.

Another remarkable speaker was Mr. Benjamin Magalong, Mayor of Baguio City has taken the initiatives to reduce GHG emissions through energy consumption. Under this strategy, the city focuses on a transformation digital programme to manage the city as a resource and provide effective strategies for the public by monitoring the valuing Air Quality Index, Urban Index, Climate Mitigation Measure, and Automated Weather Station.



# ASEAN CITY LEADERS DIALOGUE: FINDING BREAKTHROUGH AND STEPPING UP CLIMATE COMMITMENTS POST-COP26

The third session was a panel discussion, which brought together many global speakers from various institutions, among them namely: Mr. Jean Baptiste, Senior Advocacy Officer UCLG World Secretariat; Mr. Curt Garrigan, Chief of the Sustainable Urban Development Section for the Environment and Development Division of UN ESCAP; Mr. Andy Deacon, Acting Managing Director of GCoM, Mr. Yunus Arikan, Director of Global Advocacy ICLEI; and Ms. Asma Jhina, City Resilience and Climate Finance Advisor for GCoM. The panel discussion was closed by Dr. Mahesti Okitasari, Research Associate at the United Nations University Institute for the Advanced Study of Sustainability (UNU-IAS). She emphasised the importance of increasing collaboration vertically and horizontally for coherence cooperation.

At the last session, The ASEAN City Leaders Dialogue was ended by the signing ceremony session of GCoM Pilot Cities from four different countries. Some cities that have signed the GCoM Commitment letter before were not signing live during the event.

However, the commitment paper was shown and displayed on screen during the signing session. For the live session, representing Indonesia, the regent of Minahasa Utara emphasised the importance of tackling climate change.



Besides, the representative of Tam Ky City, Viet Nam, stated that they were happy to join the network and are now implementing the climate action plan. Tam Ky City also wishes to know more best practices from cities worldwide. Another representative from Viet Nam, Cao Lanh city, stated that they appreciated the efforts from different stakeholders to achieve net-zero carbon emission.



All in all, the event was closed by the Secretary-General, Dr. Bernadia, who said, "I am happy with how things played out today. However, this does not mean our climate commitment has reached a plateau. There is still much to improve and advocate for. In the end, we still have a lot of work to do."

### **ASIA PACIFIC MAYORS' ACADEMY**

Since 2019, the ASEAN Mayors Forum has been supporting the Asia-Pacific Mayors Academy as a capacity building initiative led by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), United Nations Human Settlements Programme (UN-Habitat), and UCLG ASPAC, together with the United Nations University Institute for the Advanced Study of Sustainability (UNU-IAS), Association of Pacific Rim Universities (APRU) and Institute for Global Environmental Strategies (IGES). The Academy creates a growing network of local leaders committed to sustainable development and enables the implementation of sustainable urban solutions in the region.

To date, eleven (11) ASEAN Mayors have completed their participation in the Asia-Pacific Mayors Academy and five (5) ASEAN Mayors were selected for the 2021-2022 class. The third cohort included Mayors from: Ternate (Indonesia), Sepang and Kuala Selangor District Council (Malaysia), and Iloilo and Vigan (Philippines).

The Asia-Pacific Mayors Academy is structured based on The Future of Asian & Pacific Cities (2019) Report that focused on four (4) priority areas for resilient and sustainable cities: urban & territorial planning, urban resilience, smart & inclusive cities, and urban finance. A module on COVID-19 was also introduced since 2020 to facilitate sharing of best practices in response and recovery efforts and foster bottom-up approach in building back better from the pandemic. By participating in the Academy, ASEAN Mayors gain technical support through various experts and access to knowledge and tools which strengthens their leadership and capacity to perform their mandates.







# DECLARATION ON THE SITUATION IN MYANMAR



"Following the Statement issued in February, the membership of United Cities and Local Governments (UCLG) continues to closely monitor the increasingly concerning events in Myanmar. In solidarity with the people of Myanmar, UCLG urges the respect of rule of law and the results of the democratic elections but in

particular the protection of the lives of the population. UCLG hopes representatives of local authorities will be able to assume the legitimate mandate entrusted to them by the people of Myanmar.

We join the statements made by the United Nations and ASEAN in which deep concern on the military take-over of the country have been expressed. We call on human rights to be protected and internet connections to be restored to allow communication. We stand with the people of Myanmar and want to assure them that they are not forgotten, and hope for a swift restoration of freedoms, security and peace." (UCLG World, 2022)



## LOCALISE SDGs

Local governments are key players in achieving the 2030 Agenda, also known as the SDGs. The LOCALISE SDGs programme in Indonesia, which has been implemented since 2018, seeks to strengthen the capacity of cities, local government and their associations to improve governance and development of more effective development policies and promote inclusive and sustainable regional development through the achievement of SDGs.

The LOCALISE SDGs programme is supported by grant assistance from the European Union and implemented by UCLG ASPAC, in collaboration with the Association of Indonesian City Governments (APEKSI) and involving other local government associations such as APPSI, APKASI, and ADEKSI. This program helped to strengthen the capacity of local governments in 16 provinces and 14 cities in Indonesia and network with foreign local governments and other development actors.










# FINANCIAL REPORT

## **2021-2022 TIMELINE**

AMF 29-30 June 2021

At the end of dialogue, City Leaders expressed their commitments to continue reaching zero emission by 2050

#### 6-7 October 2022

The AMF Secretariat will conduct the AMF event in Surabaya which will be hosted by East Java Province and scheduled for October 2022. The event will draw up to 200 participants (hybrid), with more than 50 mayors/governors/city representatives from ASEAN, senior local governments officials and representatives of local government associations from all ASEAN member states.

The AMF Secretariat has an intention to have the 3<sup>rd</sup> AMF event for this 2022 event side-by-side with the ASEAN Summit 2022. The AMF secretariat invites Phnom Penh City Administration as the host city for the AMF event scheduled from 14-15 November 2022. AMF is generally hosted by the city from the chairmanship's country of ASEAN; it is considered important if Phnom Penh, as the capital city of Cambodia, will be able to host the AMF event on the aforementioned date.





# CONCLUSION

Ensuring the inclusivity and sustainability of the ASEAN cities and local governments, AMF will continue to empower mayors and local leaders to maintain a network and assist city acceleration, as well as raise regional and global awareness as crucial requirements of ASEAN cities and local governments to achieve the SDGs by 2030. Going forward, AMF will continue to strive to empower and assist mayors and local leaders in gaining information, a deeper understanding of regional resources, and a supporting Southeast Asian regional network to accelerate cities' resilience and sustainability.

All in all, AMF will maintain cross-sector collaboration among mayors, local leaders and other stakeholders in developing local recovery strategies and fostering community resilience. With the fully support from the AMF, the mayors and local leaders will ease to accessing and localizing the SGDs, the Sendai Framework for Disaster Risk Reduction, and the Paris Climate Agreement, which will help the ASEAN Community to recover together and stronger as aligning with the ASEAN motto "One Vision, One Identity, One Community."
