List of services needed are as follows:

CORPORATE HEALH INSURANCE

Total Insurance Member:

- 21 persons Employee
- 8 persons Spouse
- 9 persons children from employees (daughter/son)

Health Insurance:

- Out Patient for Major Treatment (hospitalization and chronic major treatment), includes PCR Test, Vaccines, and vitamins/supplements.
- In Patient (includes hemodialisis, chemotherapy)
- Dental
- COB with BPJS Kesehatan

ASO (Administrative Service Only)*:

- Glasses (Optical)
- Medical Check Up
- Maternity

Self-funded health care, also known as Administrative Services Only (**ASO**), is a Self **insurance** arrangement whereby an employer provides health or disability benefits to employees using the company's own funds.
