## Background

United Cities and Local Governments Asia Pacific (UCLG ASPAC) is the biggest regional section of the United Cities and Local Governments (UCLG) in which its Secretariat is based in Jakarta, Indonesia, and hosted by the Provincial Government of Jakarta. UCLG is a worldwide association of local governments and the officially recognized voice of local governments by the United Nations. UCLG ASPAC has linkages to more than 7,000 local governments. It represents well over 3.76 billion people - more than half of the world population - and incorporates economically fast developing countries such as China, India, and Indonesia. UCLG ASPAC is the key knowledge management hub on local government issues in the Asia-Pacific region. It promotes democratic local government, supports cooperation between cities, local governments, and their associations, and facilitates programmes, networks, and partnerships to develop the capacity of local governments and associations. Moreover, UCLG ASPAC represents local governments politically within the international community, and with the United Nations and its agencies. It also promotes inclusive societies which safeguard equality, social and economic justice, and sustainable community development. UCLG ASPAC is engaged in all relevant thematic fields for nurturing sustainable development comprising poverty alleviation, climate change, disaster resiliency, culture, strategic planning, decentralisation, local finance, gender equality, women leadership, and empowerment as well as good governance.

As part of the consortium, UCLG ASPAC in partnership with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), and IREUS University of Stuttgart, will be engaging in one of Internationale Klimaschutzin Itiative (IKI) project – Integrated Urban Climate Action for Low-Carbon and Resilient Cities (Urban-Act). It is a four (4) years project that started in 2022 and it covers five countries. The project objectives are to enhance vertical integration and enable conditions for planning and implementation of evidence-based and inclusive urban climate action in line with Sustainable Development Goals (SDGs) and Nationally Determined Contributions (NDCs). The project will be partnering with Urban-Act (UA) partner countries such as China, India, Indonesia, the Philippines, and Thailand. The project implementation will provide targeted support both at the regional level (Asia-Pacific region), and national level (Indonesia).

The Project has the following four targeted outputs of the work plan activities: Output 1: Improved Institutional Environment for Climate-Sensitive Urban Development

National Work package:
a. Outreach on urban climate governance and policy instruments for climate-sensitive urban planning.

Output 2: Evidence-Based and Inclusive Climate-Sensitive Spatial and Urban Planning

- National Work package:
  - a. Outreach on evidence-based climate-sensitive urban planning,

b. Showcasing the integration of climate change indicators in urban development plans Output 3: Project concepts for urban climate action investments identified

- National Work package:
  - a. Outreach for urban climate action planning,
  - b. Concept note development for urban climate actions

Output 4: Enhanced Knowledge Through Regional Networking, Exchange, and Learning

- Work package:
  - a. City-to-city knowledge exchange and city pairing,

b. International and regional peer-learning and exchange

At the national level, the Ministry of Bappenas will be the political institution and for project implementation, UCLG ASPAC will be partnering with GIZ Jakarta, and in close collaboration with the selected pilot cities. To strengthen the vertical integration of Urban Climate Resilient, UCLG ASPAC will also work closely with relevant ministries such as the Ministry of Environment and Forestry (KLHK), Ministry of Home Affairs (Kemendagri), and Ministry of Finance (Kemenkeu). Therefore, the strong coordination among consortium and political partners is the key deliverable for the UA project implementation in Indonesia and UCLG ASPAC is recruiting the National Project Coordinator for a one-year (1) period with the possibility of extension, based on satisfactory performance.

## Objective and goal:

- 1. Act as focal coordinator in providing assistance to political institutions/partners, consortium partners, and pilot cities in achieving the Urban Act output in Indonesia with support from partners and experts on behalf of UCLG ASPAC;
- 2. Develop and maintain communication with external parties at all levels;
- 3. Provide the project output achievement report for the Indonesia component;
- 4. Support the management of strengthening capacity building through the delivery of national workshops/training based on the project activities.

## Key Duties and Scope of Works

- 1. Coordinating, Communications, Reporting, and Outreach (60%)
  - Regularly liaises and coordinates communications with political institutions/partners (Bappenas, Ministry of KLHK, and Kemendagri), consortium partners (GIZ Jakarta and other five GIZ Countries), and other relevant stakeholders in Urban climate resilience sectors;
  - Actively communicate with pilot cities, and/or Training Provider(s) for the development of each key sector activity;
  - Actively coordinate with Climate Project Officer and local consultants on the output achievement at the pilot cities;

- Gather feedback, questions, or other queries from pilot cities and link with partners and/or Training Provider(s) to provide the appropriate response to the queries;
- Prepare monthly reports with the Climate Project Specialist to address achievements, identity risks, and challenges in project implementation and to enhance the quality of reporting.
- Prepare monthly monitoring and evaluation reports for the project status are relevant to the development of each key sector activity;
- Work closely with the communication and knowledge management team on the learning/training activities to result in project visibility on the media platform;
- 2. Technical Management and Support (40%)
  - Work closely with the Regional Project Manager to deliver the implementation of the project activities in Indonesia in accordance with the project objectives;
  - Act as the main focal point to communicate with key stakeholders and pilot cities within the regions;
  - Bridge the communication with key stakeholders, the pilot city in Indonesia with other UA pilot cities.
  - Assist in strengthening country capacity by organising national workshops/training in achieving the project output;
  - Be responsible for the coordination and management of capacity-building events in the focused countries with the support of the Climate Project Officer, Project Administrative, and Finance Officer;
  - Contribute fully to the organisation's strategic aims and objectives, which include advocacy, capacity building, and research, as well as promote the value of its planned activities;
  - Perform any tasks from time to time as requested by the Regional Project Manager and/or the Secretary-General.

  - Demonstrated experience working with national and local governments, multi-donor agencies, and/or development partners.
