UCLG ASPAC's advocacy for empowered local governments has echoed across regional forums, placing it at the forefront of influencing governance that is truly inclusive.



Journey in Milestones



UCLG ASPAC was appointed as the coordinator for the Stakeholder Group of Mayors and Local Governments for DRR in the Asia-Pacific region under the Hyogo Framework for Action (HFA) 2 (2016-2020).

Dr. Bernadia Irawati Tjandradewi became **the first female Secretary General** of UCLG ASPAC and the first-ever at all regional sections.

Establishment of the Standing Committee on Women in Local Governments, and the decision made that the Chair of the Committee becomes the Co-President.

Adoption of the first developed UCLG ASPAC Standard Operating Procedure (SOP) for the Secretariat in various domains.

12 new members added: Bangladesh (Barisal City), India (Amalner, Gandhinagar, Himatnagar, Panchgani Hill Station, Vadodara City, Mahabaleshwar City, Satana City, Palanpur City, Ahmedabad City, Chikhli City), and New Taipei.

UCLG ASPAC office relocated from Sunter (North Jakarta) to Jakarta City Hall complex (Central Jakarta).



Formulation of the first Manifesto: UCLG ASPAC Strategic Plan 2015-2020.

Organised a pre-conference of mayors and local governments contributing inputs for the post-2015 framework for DRR, resulting in the Bangkok Declaration on Disaster Risk Reduction in Asia and the Pacific 2014 and the Asia-Pacific input for the 2nd Hyogo Framework for Action (HFA2).

6 new partnerships: 1) Changwon City, 2) Seoul Metropolitan Government, 3) Taipei City Government, 4) United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), 5) OXFAM, 6) UNITAR CIFAL Jeju.

4 new members: Indonesia (Banda Aceh City), India (Bhopal), Cambodia (National Association of Capital and Provincial Kingdom of Cambodia), Pakistan (Faisalabad).

The 5th UCLG ASPAC Congress entitled "The Adaptive City," was hosted by Taipei City. Governor Won Hee-Ryong was elected as the President of UCLG ASPAC.

UCLG ASPAC celebrated its 10th Anniversary.

In cooperation with UN ESCAP, the first physical construction project, Waste to Energy - the Integrated Resource Recovery Center (IRRC), was executed in Jambi City and Malang Regency.



2015

Formation of the UCLG ASPAC Committee on Culture by Jeju Special Self-Governing Province under the leadership of Governor Won Hee-Ryong and establishment of the UCLG ASPAC Standing Committee for Southeast Asia.

UCLG ASPAC Secretary General appointed as Advisory Group member on Gender Issues (AGGI) of UN-HABITAT.

Published "South-South Cooperation: Best Practices and Replications."

Establishment of the UCLG ASPAC Internship Programme for University Students.

5 new partnerships: 1) UCLG Eurasia, 2) World e-Governments Organisation of Cities and Local Governments (WeGo), 3) CityNet and Seoul Human Resource Development Center (SHRDC), 4) KAS, 5) Wakatobi Regency Government.

Formation of Asia-Pacific Local Government Coordinating Body (APLG).

The 4th ASEAN Mayors Forum held jointly with the Centre for Liveable Cities of Singapore Government, aligned with Singapore as the 2018 ASEAN Chairmanship.

Accreditation of ASEAN Mayors Forum as the first Entity of Local Governments Associated with ASEAN.

UCLG ASPAC led the stakeholder consultation of local authorities with UNISDR on AMCDRR.

2019

On behalf of APLG, delivered the Local Government statement at the 6th Asia-Pacific Forum on Sustainable Development held in Penang. UCLG ASPAC also held the Local Government Assembly as a preforum event of APUF-7 and presented its Voluntary Commitment.

UCLG ASPAC engaged 16 new partners, the highest number for partnerships in a year, with the Association for Development of Local Governance in Pakistan (ADLG), Cassandras a Media and Consultancy Hub LLP, Cités Unies France (CUF), Daegu Metropolitan City, Jeju City, Jeonju City, Local Council Association of Balochistan (LCAB), Local Council Association of Sindh (LCAS), Majlis Bandaraya Seberang Perai, Parliamentary Task Force on SDGs, Raoul Wallenberg Institute (RWI), RWI and Gwangju, Surakarta City Government, The World Association of the Major Metropolises, UN ESCAP, UN-HABITAT.

6 new members added: Indonesia (Bontang City, Gorontalo City, Jayapura City, Jember Regency), South Korea (Korean Research Institute for Local Administration - KRILA), China (Siping City).

The Asia-Pacific Mayors Academy was launched by UNESCAP and UN-Habitat, in collaboration with UCLG ASPAC, UNU-IAS, and APRU. UCLG ASPAC acts as the permanent member of the Academy's advisory board.

UCLG ASPAC collaborated with UNESCAP and the Bangkok Metropolitan Administration in convening the 5th ASEAN Mayors Forum at UNCC in Bangkok, Thailand.

UCLG World Secretariat Congress in Durban, South Africa elected Mayor of Iriga, Ms. Madeleine Afelor as UCLG World Treasurer, and Mayor of Xi'an City, Mr. Li Mingyuan as UCLG Co-President. This is the first time that the Treasurer is from the Asia-Pacific region.

Supported the development of the Voluntary Local Review (VLR) of Hamamatsu.

UCLG ASPAC's contribution to the Asia-Pacific Chapter is included in the "GOLD V 2019 Report."

Delivered Local Government intervention supporting policy recommendations in accelerating decentralisation and providing financing frameworks for cities at the 7th APFSD.

Published The Asia-Pacific Regional Guidelines on Voluntary Local Reviews in partnership with Penang Platform for Sustainable Urbanisation (PPSU).

7 new members added: Indonesia (Bandar Lampung City), Nepal (Birgunj Metropolitan City, Dhankuta Municipality, Tulsipur Sub Metropolitan City), China (Guiyang Municipal People's Government, Wuxi Municipal People's Government), and South Korea (Sejong City).

After more than 118,000 cases in 114 countries and 4,291 deaths, the WHO declares COVID-19 a pandemic.

Tri Rismaharani, Mayor of Surabaya, President of UCLG ASPAC for 2018-2020, she was inaugurated as Indonesia's Minister of Social Affairs. Mayor Ashok, President of MuAN and Mayor of Dhulikhel, became the new President of UCLG ASPAC.

Published "Human Rights Localisation Handbook" in collaboration with RWI.

Organised the blended Learning Course (BLC) on Human Rights Localisation in the Context of the SDGs Human Rights Festival in Semarang

On behalf of APLG, delivered a Local Government statement on three key actions that support the implementation of SDGs at the local level at the 8th APFSD.

The 8th UCLG ASPAC Congress "From Steady Recovery to Sustained Prosperity in Post COVID Asia Pacific" was hosted by Zhengzhou in a hybrid format.

Completion of VLR Jakarta, VSR Philippines, VSR Sri Lanka, and VSR Pakistan.

On behalf of APLG, underscored the pivotal role of local governments and called for support by providing access to financing mechanisms, and institutionalisation of synergies between VNR, VSR, and VLR at the 9th APESD.

Capacity Building Session for National and Provincial Parliamentary Taskforces on SDGs was organised in Pakistan, resulting in the development of an Action Plan for Strengthening and Optimal Functionality of the Parliamentary Taskforces on SDGs in Pakistan.

4 new partnerships: Kuala Lumpur City Hall, UCLG Africa, UCLG MEWA, FCM.

The 7th UCLG World Congress in Daejeon adopted **the Pact for the** Future of Humanity.

Supported the organisation of Urban 20 Mayors Summit in Jakarta, and co-hosted "Digital Governance in Accelerating Sustainable Development and Climate Resiliency." In collaboration with Indonesia's Ministry of Home Affairs (MoHA), held an International Seminar, "Road to Indonesia's G20 Presidency," to foster collaboration among cities to accelerate solutions for climate change, the pandemic, and economic recovery.














Advocacy and Capacity Building

The UCLG ASPAC Manifesto 2015-2020 identified the ability to leverage policy through active advocacy efforts as one of UCLG ASPAC's strengths. In the Manifesto, advocacy became one of the strategic goals, particularly Strategic Goal 4 - Aggregate, Elevate, and Advocate Local Voices and Issues at National. Regional, and Global Levels. Under the leadership of UCLG ASPAC Secretary General Dr. Bernadia Irawati Tjandradewi, an internal policy team was created at the Secretariat in 2022 to support the implementation of the advocacy plan. This team facilitates internal consolidation of advocacy efforts within UCLG ASPAC and external consolidation with the advocacy efforts at the global level through UCLG World.

To date, there have been a total of 19 statements of local governments/authorities produced for regional and sub-regional events in Asia-Pacific.

- Seven (7) were on sustainable development presented at APFSD and APUF,
- Three (3) on disaster risk reduction presented at APMCDRR,
- Six (6) were on ASEAN urban issues presented at AMF, and
- Three (3) were on migration presented at the Abu Dhabi Dialogue and Asia-Pacific Regional Review of Implementation of the GCM.

Advocacy Frameworks and Principles

Policy advocacy is woven into every UCLG ASPAC project, programme, coalition, and committee, employing and combining the principles of at least two advocacy frameworks. The advocacy planning framework identifies the challenge, UCLG ASPAC leverage, way into the process, messenger or "Champion Mayors," and the corresponding message and activities. The advocacy coalition framework indicates how policy participants coordinate their behaviour with allies in advocacy coalitions to influence policy.

Role and Impact of UCLG ASPAC's Advocacy:

Below are several platforms where UCLG ASPAC has been active in amplifying the echo and bringing the voices of local governments and shaping the regional's perspectives.

Asia-Pacific Local Government Coordinating Body (APLG)

The APLG, established in 2018, serves as a regional coordination mechanism to better coordinate regional advocacy for local authorities. It extends its active involvement from the Asia-Pacific Forum on Sustainable Development (APFSD) to other regional forums and processes, amplifying the voices of local governments on various issues. UCLG ASPAC serves as the coordinator of APLG.



Asia Pacific Forum on Sustainable Development

Since 2019, UCLG ASPAC facilitated the participation of local governments at the APFSD, delivering statements and organising the Local and Regional Assembly and other relevant topics as side events. The chair's summary of discussions consistently cited local governments, showcasing the significant outcomes of UCLG ASPAC's advocacy work at the APFSD.



ASEAN Mayors Forum (AMF)

As the host for AMF, UCLG ASPAC plays a crucial role in facilitating networking, policy debates, and knowledge exchange among cities and local governments in ASEAN. The forum's evolution, from adopting declarations to addressing critical issues like circular economy and migration, underscores UCLG ASPAC's commitment to advocating for accountable local governance. AMF received an accreditation from ASEAN as an affiliated ent



Asia-Pacific Ministerial Conference on Disaster Risk Reduction (APMCDRR)

UCLG ASPAC's engagement in the APMCDRR, from 2013 onwards, highlights its commitment to promoting coordination and cooperation on disaster risk reduction. 


Empowering Local Governments



In fostering empowerment for newly-elected or appointed mayors/governors in the Asia-Pacific region, the Asia-Pacific Mayors Academy, inaugurated in 2019, stands as a beacon of positive impact through robust capacity-building programmes. Developed in collaboration with influential organisations such as UN ESCAP, UN-Habitat, and UCLG ASPAC, the Academy's curriculum not only delves into crucial urban development aspects but also adapts to evolving challenges. A noteworthy addition in 2020 addressed the pressing issues of COVID-19 response and recovery, showcasing the Academy's agility in responding to real-world challenges. With UCLG ASPAC playing a pivotal role as a permanent Advisory Board member, the Academy has become a dynamic force for sustainable urban development. Despite gender balance challenges, the programme's completion rate of 63.83% is a testament to the commitment of 30 out of 47 mayors, receiving well-deserved certificates for their dedication to advancing positive change in their communities. The Academy's ripple effect extends across the Asia-Pacific region, with prominent representation from nations like the Philippines, Malaysia, and Nepal.

Empowering Local Governments by Bridging Knowledge to Actions

UCLG ASPAC plays a crucial role in capacity development through its appointment as a Service Provider by the International Development Cooperation Directorate of the National Development Planning Agency (IDC-Bappenas) in Indonesia. The collaboration with Research Triangle Institute (RTI International) under the Australia-Indonesia Partnership for Pro- Poor Policy – The Knowledge Sector Initiative (KSI) focuses on capturing and translating knowledge into actionable materials. The overarching objective is to facilitate the successful replication of smart practices in targeted regions, emphasising the development of knowledge products and enhancing the capacities of local governments through tools and methodologies. This initiative underscores UCLG ASPAC's commitment to empowering local authorities with the insights and resources needed for impactful development.

Strengthening Local Governments' Capacity for SDGs Reporting

UCLG ASPAC actively engages in facilitating SDGs voluntary reporting documents to enhance the monitoring and reporting mechanisms for local governments and their associations. Since 2019, UCLG ASPAC has supported the development of Voluntary Local Reviews (VLRs) and Voluntary Subnational Reviews (VSRs) for several members. The initiative began with the first VLR and VSR, for Hamamatsu and Indonesia, respectively, representing the perspective of SDGs attainment progress from the subnational governments. It was then continued with the first VLR at the city level in Indonesia, which is the VLR for Surabaya City, and the first VLR at the provincial level, VLR for Jakarta. In 2022, the support expanded to include the development of VSRs for the Philippines, Sri Lanka, and Pakistan, and in 2023 for Cambodia. Ongoing assistance for VLRs is also in progress for UCLG ASPAC members. These reports not only provide a comprehensive overview of SDGs attainment by 2030 but also offer valuable insights for enhancing SDGs localization through legal and institutional reforms at the local level.

UCLG ASPAC Committees

UCLG ASPAC Committees aim to strengthen collaboration and cooperation among UCLG ASPAC members, promote good and exemplary practices of ASPAC cities and local governments, gather experts and stakeholders interested in local governments issues, and share knowledge and experience among UCLG ASPAC members. Furthermore, they are instrumental to the implementation of the UCLG ASPAC strategic plan, the latest of which is referred to as the UCLG ASPAC Manifesto 2021-2025.



Advancing Gender Responsive and Participatory Budgeting

In a recent positive stride towards gender inclusivity, UCLG ASPAC held a two-day Learning Workshop on Gender Responsive and Participatory Budgeting (GRPB) in February 2023, at the Institute Dewan Latihan Bandaraya (IDB) or Kuala Lumpur Training Centre in Kuala Lumpur. The activity was part of our commitment as reflected in the MoU signed with Penang Women's Development Corporation (PWDC) and UN-HABITAT. This initiative aimed to enhance the capacity of local governments to understand GRPB content and mechanisms, providing tools to translate learning into impactful GRPB test projects in their respective localities. This workshop marks a positive step forward in our efforts to promote gender responsiveness, with future monitoring and advancements in the pipeline. The workshop concluded with four cities/local governments submitting GRPB test projects in Malaysia, serving as pilot initiatives for further positive transformations.

Gender mainstreaming has been an integral fragment of the Standing Committee on Women in Local Governments currently led by Guangzhou, which also includes UCLG ASPAC's efforts to have more women leaders participate in its Governing Body.

Caring City for Inclusive Urban Development

In a collaborative effort, SHRDC, Metropolis, UCLG, and UCLG ASPAC orchestrated the Online Training Programme on Caring Cities in July 2023. This initiative aimed to heighten awareness and knowledge among cities and local governments on inclusive urban development management, with a specific focus on benefiting vulnerable groups through local development initiatives. Fifteen cities from diverse regions actively participated in the live sessions, fostering cross-regional learning and exchange. The Asia Pacific region, with cities such as Alaminos, Antipolo, Baguio, Makati, Olongapo, Puerto Princesa from the Philippines, Palembang, Yogyakarta, Jakarta, Minahasa Utara from Indonesia, Kathmandu, Shivasatakshi, Vyas from Nepal, and Male from Maldives, contributed significantly to the programme's success.

100 Human Rights Cities at the World Level


UCLG ASPAC supports the global target of having 100 human rights cities. In a strategic collaboration initiated in 2019, UCLG ASPAC partnered with the Raoul Wallenberg Institute (RWI) and Gwangju City to promote the institutionalisation of human rights within local government policies and planning processes. In 2021, the partnerships included key activities such as the Blended Learning Course on Human Rights Localisation, the development of the Human Rights Localisation Handbook, participation in the World Human Rights City Forum (WHRCF) in Gwangju, and co-organisation of the Human Rights Festival in Semarang. These various activities showcased UCLG ASPAC's dedication to enhancing local governments' capacities in mainstreaming human rights and reflecting its commitment to regional dialogues, such as the Regional Dialogue on Human Rights and Local Governance in Asia and the Pacific in September 2023.



Sustainable Mobility, the Key to Build Care Cities


UCLG ASPAC's unwavering commitment to sustainable mobility is exemplified through capacity-building initiatives, fostering success stories, and encouraging peer cooperation amongst cities and local governments in the Asia-Pacific region. Recognising the transformative potential of urban public transport services, UCLG ASPAC has conducted various activities over the decade. The regular training programmes with the Seoul Human Resources Development Center (SHRDC) in Seoul, the development of action plans, the workshop in Salatiga and South Tangerang in Indonesia, facilitation of city-to-city cooperation on mobility, are a few activities to mention.

Facilitated by UCLG ASPAC, 14 representatives from Indonesian cities established the Local Government Transport Office Forum (LGTOF) in 2015 as a follow-up action to the Sustainable Mobility Workshop organised in cooperation with SHRDC. Action plans developed by participating cities as part of the Workshop have been carried out including the reorganisation of the public transport feeders in Surakarta.



International Talent Education Programme for Cities And Local Governments

Xi'an –Education for Cultural Understanding. In 2021, as the leading City of the Tourism Committee, the Xi'an Municipal People's Government, in partnership with UCLG ASPAC and Xi'an Jiaotong University, established a scholarship programme to enable members to pursue Master's and Doctoral Degrees at Xi'an Jiaotong University. The Xi'an Municipal People's Government has also extended its support by offering Chinese Learning Classes (online) to UCLG ASPAC members. This initiative is an integral component of the UCLG ASPAC Tourism Committee's capacity-building programme, emphasising the commitment to fostering educational opportunities and cultural understanding among its esteemed members.

Localising SDGs: Our Journey from Indonesia to Pakistan and Contribution to the Global Agenda

The LOCALISE SDGs programme in Indonesia, initiated in 2018, is the first programme of UCLG ASPAC funded by the EU that was spearheaded to mainstream SDGs in local planning across Indonesia. Tackling challenges such as low awareness, a lack of enabling environment, and weak capacities among local governments (Lgs), the programme empowered 30 LGs and five LGAs (local government associations), integrating SDGs governance significantly into their development plans.

Despite the challenges posed by the COVID-19 pandemic, **LOCALISE SDGs demonstrated remarkable achievements.** All targeted LGs have incorporated SDGs into their mid-term development plans, completed Local Action Plans, and showcased best practices on international platforms.

The capacity-building efforts, including online training and research on COVID-19 responses, highlighted its success. The LOCALISE SDGs project managed to reach a total of 6,275 participants: 68% were virtual event participants, 26% were local training participants, 4% were national training participants, and 3% were city diplomacy training participants. The activities also strived to achieve gender balance with the participation of 55% male participants (3,451) and 45% female participants (2,824), reflecting the active involvement and commitment of LGs to not leaving anyone behind. Noteworthy publications include pocketbooks for decision makers and a compilation of LAs' good practices, and five thematic cross-sectoral research contributing to SDGs attainment within the context of the COVID-19 pandemic.

LOCALISE SDGs Programme in Indonesia (2018-2021):

- 30 Cities and Local Governments incorporated SDGs in mid-term plans.
- 6,275 local governments and stakeholders obtained training on SDGs localisation.
- Engaged over 15,000 website users and reached over 125 million people through media.





SGDs Localisation in Pakistan-inspired by Indonesia. Building on the successful LOCALISE SDGs in Indonesia, UCLG ASPAC extended the efforts to localise the SDGs in Pakistan through the 'Local Empowerment, Advocacy, and Development (LEAD) for SDGs Localisation' project. Launched in 2020 and co-funded by the European Union, the primary focus is enhancing institutional capacity and strengthening local governments in Pakistan to localise the SDGs and to achieve the 2030 Agenda. In 2021, the project conducted analyses on budgetary allocations for SDGs, considering the impact of COVID-19 on government priorities. A rapid assessment of parliamentary SDGs Task Forces identified challenges, leading LEAD for SDGs to sign memorandums of understanding for technical and financial support. LEAD for SDGs focuses on capacity building through training for Provincial and Local Government.

The project also involves the development of SDGs-aligned District and Local Plans in collaboration with communities. The training initiative, titled 'SDGs Mainstreamed Planning, Monitoring and Reporting,' started with the training of trainers that aimed to set up a capacity-building plan for stakeholders, particularly local governments in Balochistan and Sindh Provinces. The LEAD for SDGs targeted 64 districts with the support of LCAs in both provinces. A total of 606 participants attended the knowledge and capacity-building trainings, with a focus on mainstreaming SDGs in local development planning, monitoring, and reporting. Out of these participants, 420 were local government officials, including 40 women.





Climate and Disaster Resilience Planning and Actions



In the dynamic landscape of the Asia-Pacific region where over 50% of the population resides in cities, the challenges of urbanisation are compounded by the fact that 40% of global disasters occur in this region. Climate change further amplifies these vulnerabilities, making resilience a pressing concern. UCLG ASPAC plays a crucial role in fortifying resilience by championing policies, facilitating knowledge exchange, and fostering collaborative partnerships. This commitment not only aligns with Disaster Risk Reduction (DRR) initiatives but also positions UCLG ASPAC as a key player in steering the Asia-Pacific region toward a more resilient and sustainable future.

UCLG ASPAC in the Global Covenant of Mayors (GCoM) for Climate and Energy

Assigned as the GCoM Southeast Asia (GCoM SEA) Secretariat since 2018, UCLG ASPAC supports cities and local governments committed to climate and energy to achieve low-carbon and climate-resilient developments, and engages in coordination and partnership with GCoM SEA partners. With 109 GCoM signatories from countries like Indonesia, Malaysia, the Philippines, Thailand, and Vietnam, the GCoM SEA Secretariat facilitated 28 pilot cities in developing Climate Action Plans (CAP). This inclusive initiative signifies a proactive approach to mainstreaming climate resilience in urban development. The success stories include Palembang receiving the City Climate Gap Fund in 2021 and Malang and Tam Ky being included in the Transformative Action Program (TAP) pipeline in 2022.













The Climate Resilient and Inclusive Cities (CRIC)

Co-funded by the EU, UCLG ASPAC is making significant contributions to climate resilience planning and implementation. Training series on climate action plans and GHG emissions mapping are some of the many activities under the CRIC project. From 2020 to 2022, CRIC has trained 1,242 individuals, impacting 3,404 directly and 167,222 indirectly. The project strengthened institutional capacities with the formation of Climate Change Working Groups in its 10 pilot cities. Looking ahead, CRIC aims to finalise climate action plans, develop tools, continue knowledge dissemination, and continually collaborate with national entities in Indonesia. This signifies integration into broader climate action frameworks in Indonesia, underlining CRIC's pivotal role in shaping climate actions and fostering sustainable cities.

Transforming Solid Waste for Sustainable Cities and Territories









The Integrated Resource Recovery Centers (IRRCs) is the first project that UCLG ASPAC carried out in collaboration with UN ESCAP in 2014. Aiming to reduce and regulate waste while utilising it as a new energy source, the IRRC can reduce 80-90% of waste to be efficiently processed in a decentralised manner by converting organic fractions of waste into biogas through anaerobic digestion. The IRRC system, exemplified in pilot projects like Jambi City and Malang Regency, processes organic waste into compost and generates electricity through a biodigester.

This approach not only efficiently produces compost, comprising 80% of total waste weight, but also addresses landfill site congestion by utilising market waste and cow manure. The compost serves as nutrient-rich material for soil and plants, offering environmental benefits and saving costs associated with waste transportation. The successful pilot projects showcase the potential of waste-to-energy solutions, emphasising a commitment to sustainable waste management practices.



Pioneering Inclusive Urban Sanitation in South Asia

UCLG ASPAC mainstreams SDGs 6.2, Sanitation for All, in Bangladesh and Nepal. In partnership with the BMGF, the Organisation has spearheaded the Municipalities Network Policy Advocacy on Sanitation in South Asia (MuNASS) project since 2017. The initiative enhances the capacity of LGAs, with a specific focus on Faecal Sludge Management (FSM) and Non-Sewered Sanitation (NSS). Having completed its first phase in December 2020 and launched the second phase in March 2022, MuNASS garnered acclaim for fostering enabling policies aligned with SDG 6.2.

In South Asia, MuNASS Phase II mobilises cities to innovate in safely managed sanitation, prioritising women and vulnerable populations. It documents municipal-led investments for City Wide Inclusive Sanitation (CWIS) and FSM, mainstreams Goal 6.2 into the regional agenda, and engages LGAs across Bangladesh, Nepal, Sri Lanka, and expanded to Cambodia, Vietnam, and Indonesia. UCLG ASPAC's efforts, exemplified by MuNASS, have been instrumental in advancing sanitation policies, fostering regional collaboration, and advocating for inclusive urban sanitation, particularly addressing SDG 6.2 with a focus on marginalised communities.



Public Space for All

UCLG ASPAC's work in enhancing public spaces and urban development have left lasting imprints across the Asia-Pacific region. Recognising the critical role of cities in the global landscape and the challenges faced by urban populations, UCLG ASPAC employs a bottom-up and participatory approach to empower local governments. Through collaborative projects, the Organisation has successfully developed and/or revitalised key public spaces, fostering community engagement and inclusivity.

In Surakarta, Indonesia, UCLG ASPAC facilitated the revitalisation of the "Wayang Orang Sriwedari," a theater building dedicated to art and culture. The participatory design approach ensured the preservation of cultural heritage, with the redesigned space accommodating diverse community activities. In cooperation with Jeju Province, UCLG ASPAC extended the work beyond physical spaces to cultural initiatives. The "Jeju Province – Surakarta City Cooperation on Culture and Arts for Youth Development" project in 2019 facilitated knowledge exchange among young artists, emphasising the role of culture in sustainable urban development. This added the beautiful public space constructed at the children's playing ground.



Similarly, in cooperation with UN Habitat, the Creative Public Space projects in Tanah Kali Keputih, Surabaya and Ketandan Cultural Hall revitalisation showcased UCLG ASPAC's commitment to addressing the needs of low-income communities, providing essential facilities, and promoting inclusivity.









In Seberang Perai, Malaysia, the Bandar Perda Eco-corridor project in 2019 demonstrated UCLG ASPAC's dedication to enhancing accessibility, connectivity, and environmental awareness. The public space development aligns with the community's needs and contributes to the unique identity of Bandar Perda. The success of these projects underscores the Organisation's ability to catalyse positive change and promote sustainable urban development.

Amid the challenges posed by the COVID-19 pandemic, UCLG ASPAC demonstrated resilience and adaptability. The "Tackling COVID-19 through Re-thinking Public Space: Digital Public Realm" project in Yogyakarta responded to new realities by developing a web-based platform, ensuring the continued provision of daily needs, supporting local farmers, and improving local supply change.













These diverse projects collectively showcase UCLG ASPAC's commitment to creating liveable, equitable, and resilient cities across the Asia-Pacific region. Through collaborative and participatory approaches, the Organisation continues to contribute significantly to urban development and the well-being of local communities.

Facilitating Decentralised Cooperation for Sustainable Development

From 2013 to 2023, the Organisation has evolved into a pivotal knowledge management hub, championing democratic local governance, fostering collaboration among cities, local governments, and associations, and spearheading programmes that enhance the capacity of these entities. This transformative journey aligns with the principles of good governance, accelerating the attainment of sustainable development.

UCLG ASPAC witnessed a notable surge in interest and intention among member cities to collaborate within and beyond the Asia-Pacific region. The lifting of physical mobility restrictions post-COVID-19 further catalysed these initiatives. Some of the recent agreements for cooperation established in 2021-2022 include:

Supported friendly exchange agreements between Zhengzhou Municipal People's Government and Balykchy City, Federation Sri Lankan Local Government Authorities, and Kathmandu Metropolitan City (Sept. 2021)

Facilitated collaboration between Guangzhou Municipal People's Government and Jambi City, focusing on education, tourism, culture, youth engagement, and health (July 2021)

> Facilitated cooperation between Xi'an Municipal People's Government and Daejeon Metropolitan City, Xi'an Municipal People's Government and Dhulikhel Municipality, and Xi'an Municipal People's Government and Kuala Lumpur (October 2022)





Solidarity Amidst the COVID-19 Pandemic

The COVID-19 pandemic has impacted people all over the world. In the spirit of humanity, UCLG ASPAC played a crucial role in fortifying solidarity among its members during this challenging time. Initiatives included generous donations from UCLG ASPAC members in China and South Korea, aimed at supporting cities and local governments in Indonesia and Nepal. Examples of donated goods included essential medical supplies such as surgical masks, face shields, gloves, protective clothing, oxygen concentrators, nasal high-flow oxygen therapy devices, infusion pumps, and oximeters. Furthermore, UCLG ASPAC's proactive efforts extended to post disaster rehabilitation programmes in Palu City, initiated in October 2019. Conducted under the auspices of the UCLG Taskforce for Territorial Prevention and Management of Crisis, with support from Cities Unies France (CUF), the programme was implemented during the global COVID-19 pandemic in 2020. Focusing on capacity-building, SME support, and local economic recovery, it engaged stakeholders through activities like stakeholder mapping and needs assessment, revealing crucial findings and informing rehabilitation projects.

Prioritising a Disaster Risk Study in Balaroa, the programme contributed to benchmarking disaster-resilient local strategies. The construction of a Public Facility and Memorial Wall in May 2022, which now serve as a community centre, highlights the community's resilience and commitment to rebuilding Palu City.



Starting with 5 staff only in 2013, the Secretariat has now expanded to reach about 40 staff members and consultants The project revenue has increased from USD 120,333 in 2013 to nearly 2 million in 2023 (as of September 2023). Over her tenure, UCLG ASPAC has more than 120 partnership agreements, has increased 100 % of newmembers, and received recognition from more than 70 partners.

Streamlining Operations: Behind-the-Scenes

UCLG ASPAC Secretariat actively collaborates with partners to transform visions into tangible outcomes. Through advocacy, knowledge sharing, and capacity enhancement for members, the Secretariat plays a crucial role in advancing the interests of our members.



People-Centric Approach:

Valuing employees as the driving force, the Secretariat empowers individuals to make a meaningful impact. Continuous improvement, professional development, and healthy working relationships contribute to achieving higher performance standards. The Secretariat has made significant advancements in various areas, such as the implementation of a learning organisation structure by utilising the e-Learning platform to support the staff onboarding process. Others are learning opportunities for staff, i.e. Training for Business English and Project Management as well as other Professional Certifications.



Project Management, Administrative and HR Procedures Advancements:

Over the past decade, the Secretariat has undergone notable advancements in administrative and human resources functions. This includes transitioning from limited resources to a slightly increased workforce. The first Standard Operating Procedure (SOP) was created in 2013 and in 2020, its enhancement was made for Project Management.



Positive Workplace Culture:

The Secretariat's initiatives have fostered a positive workplace culture, evident in regular team-building retreats, open communication, and mutual respect among employees.



Streamlined Operations:

The Secretariat has invested in tools like the HR Integrated System Platform, implemented in July 2020. This online-based tool significantly improved the quality of HR Database and Reports. The deployment of an Enterprise Resources Planning (ERP) System has just started to enhance the integration of finance and administration procedures.



Employee Engagement Strategies:

Over a 10-year period, the Secretariat has implemented much diverse strategies, including empowerment, flexibility, and well-being programmes. As post-COVID-19 policy, employees are able to work from home once a week. Staff members have also an increase annual leave entitlement to 18 days. These demonstrate a commitment to work-life balance and employee well-being.




Commitment to Gender Equality:

The Secretariat is committed to gender balance, aiming for 50% female representation by 2023. This commitment is reflected in the Gender Equity Policy and sends a positive message about the organization's values and goals. Currently, as of 2023, the Secretariat has achieved 51% female representation (18 out of 35 people).

UCLG ASPAC'S Human Resources

UCLG ASPAC Secretariat is committed to engaging existing employees and future talent. The Secretariat headcount grew from 5 people in 2013 to the highest of 44 people in 2020, with 35 people by the end of 2023. This growth signifies the Secretariat's continuous efforts to enhance its operations and support UCLG ASPAC's mission.





Chart 1. Human Resource at the Secretariat from 2013-2023





Members and Youth Engagement at the Secretariat



Internship Programme:

Initiated in 2014, the programme aimed at engaging youth in international activities as a form of our commitment to nurturing the next generation. This programme attracts interns from Indonesia and countries like South Korea, China, Vietnam, the Philippines, Italy, and New Zealand. The number of interns has steadily increased, reaching 17 students in 2022. Interns actively participate in various tasks, concluding their period with presentations and final reports and providing them with the certificate.





Secondment Programme:

Launched in 2019, the programme aims to promote public service exchange among UCLG ASPAC members. Supported by an MOU, this initiative has seen active participation from China (Guangzhou) and South Korea (Seoul, Changwon and Daegu), with secondees experiencing organisational management and diverse cultural contexts. South Korea sent secondees in 2019, 2020, and 2021, while China participated in 2019.

Balancing the Books: Achievements in Financial Management

UCLG ASPAC's financial journey from 2013 to 2023 has been transformative, evolving from a membership-fees-only major revenue to strong donor-funded programmes for the Organisation. Its financial landscape has turned out to be more intricate, with a growing portfolio from collaborations with major donors, such as the EU, Bill & Melinda Gates Foundation, UN Agencies, and contributions from members mainly for Committees' activities.

Assets

UCLG ASPAC assets or 'cash and equivalent' has grown higher from time to time. It has more than 5 (five) times increments from 2013 to 2023 (as of 30 September 2023). This was contributed by the membership growth and programme fundings over the decade. There were assets declines in 2020 and 2022 when UCLG ASPAC has not received funding payment from the donors, meanwhile the programmes kept spending the existing budget and donors funding were received only following year.

Membership Fees Revenue

UCLG ASPAC's membership revenue is relatively steady. It tends to rise in tandem with its growing memberships. The Organisation faced a temporary decline during the COVID-19 pandemic (late 2019 to 2021), however, a rebound was observed in 2022, demonstrating resilience and adaptability in membership revenue generation.

Projects and Programmes Revenue

Engaging in projects and programmes with diverse donors has significantly boosted UCLG ASPAC's revenue, surging from a few USD in 2013 to nearly USD 2 million by 2023. Major donors have played a pivotal role in supporting projects programmes across the region. It was extended beyond Indonesia to countries like Pakistan, Nepal, and Bangladesh. Fundings were used for advocacy, training and learning, and physical constructions as well.




Chart 5. Revenue from programme funding increased significantly in 202

Substantial Financial Management Transformation

UCLG ASPAC has undergone a substantial financial management transformation through the implementation of the SAGE accounting software. This robust system, fully operational since 2015, ensures accountability and transparency, meeting the stringent financial standards set by international donors.

To further enhance efficiency and integration, UCLG ASPAC embarked on developing a custom Enterprise Resource Planning (ERP) system using Microsoft Dynamics 365 Business Central. This system, implemented in January 2023, seamlessly integrates human resources, procurement, operations, project management, and accounting. The ERP not only automates bookkeeping but also facilitates day-to-day activities for staff, such as attendance records, travel requests, and procurement processes. Future modules are in the pipeline, including Membership Database and Salary-Payroll modules, showcasing UCLG ASPAC's commitment to continuous improvement and innovation in financial management.

Developed Modules in ERP using Micosoft Dynamic 365 Business Central are as follow:

- 1. Human Resource
- 2. Key Performance Indicator (KPI)
- 3. Procurement
- 4. Finance & Accounting
- 5. Grant Management

For future development, UCLG ASPAC plans to develop the following modules:



Seoul

A powerhouse capital of South Korea, Seoul has been honoured with the prestigious United Nations Public Service Awards (UNPSA). In 2015, Seoul was recognised in the "Promoting Gender-Responsive Delivery of Public Services" category for its "Making Seoul a Safer City for Women" project. The initiative, driven by the Women Policy Division, encompassed educational programmes, the creation of supportive networks, and the establishment of a comprehensive reporting protection system.

Noteworthy impacts include the mobilisation of over 1,000 citizens as volunteers, the designation of 656 convenience stores to assist women in danger, and the assistance of 4,561 women through the reporting system. In 2019, Seoul received another UNPSA, this time in the "Promoting Gender-responsive Public Services to Achieve the SDGs" category, for its "Public Sanitary Pads Support Policy." This initiative, aligned with several SDGs, began in 2016 and evolved into a national project, providing sanitary pads to low-income teens that have created a positive social impact.

The recipients, Kushtia Municipality in Bangladesh and Ratnagar Municipality in Nepal, not only gain well-deserved recognition but also become champion leaders in the field. The next set of awards is scheduled on November 2023 at the UCLG ASPAC Congress in Yiwu.






