OPENING CEREMONY

Mr. Wang Jian, Party Secretary of the CPC Yiwu Municipal Committee, briefly discussed Yiwu's extensive experience and contribution in trade. He indicated Yiwu's willingness to strengthen ties in trading and investment that will contribute to the development and prosperity of the Asia-Pacific region.

Mr. Ashok Kumar Byanju Shrestha, Immediate Past President of UCLG ASPAC and Mayor of Dhulikhel Municipality, emphasised the need to foster cooperation among local and regional governments and with other stakeholders, and to leverage the opportunities of digital economy, global value chains, and youth, as drivers of economic transformation and social change.

“The stories of Zhejiang and Yiwu demonstrate, in very vivid terms, the striking features of China's economic growth, openness, innovation, inclusiveness, cooperation and win-win mentality.”

Mr. Shi Zhongjun, Secretary General of ASEAN-China Centre, considered the four following priorities for the future: building open and inclusive system of cooperation, securing high-standard regional economic integration, exploring new domains of practical cooperation, and enhancing amity and trust among people. The ASEAN-China Centre (ACC) is an intergovernmental organisation established by China and the Association of Southeast Asian Nations (ASEAN) to promote practical cooperation and has been committed to strengthening exchanges and cooperation among the cities and local governments of China and ASEAN countries.

He added that UCLG is an important platform for multilateral exchanges and cooperation of cities in the world.



MAIN FORUM



KEYNOTE SPEECH

“As we move forward, we must keep in mind that economic development is not an end in itself. It is a means to an end, and that end is to improve the lives of our people.”

Dr. Bernadia Irawati Tjandradewi, Secretary General of UCLG ASPAC, recommended focusing on inclusive growth, sustainable development, innovation and technology, and collaboration, for cities and local governments to advance balanced economic development. She expressed confidence that the shared values and vision of UCLG ASPAC can foster prosperity for the people.



Dr. Bernadia Irawati Tjandradewi presented a keynote speech at the Main Forum.

“To further promote economic integration and institutionalisation in the East Asian region, we should work together on various economic cooperation arrangements.”

Mr. Lee Hee-sup, Secretary General of Trilateral Cooperation Secretariat, underscored the significance of the Regional Comprehensive Economic Partnership (RCEP) as the first trade agreement that united China, Japan, and the Republic of Korea which can also bring numerous benefits to the ASEAN member states. He recommended enhancing the level of liberalisation of RCEP, ensuring complementarity and cooperation with other economic agreements, and restarting the negotiation on the free trade agreement between China, Japan, and the Republic of Korea.



Mr. Lee Hee-sup delivered a keynote speech at the Main Forum.

“The world and mankind can only achieve development and progress through the creation of value.”

Mr. Cai Jin, Vice Chairman of China Federation of Logistics & Purchasing, Asia-Pacific Regional Chair of the International Federation of Purchasing and Supply Management, reported on the China logistics industry which serves as a pillar industry of the national economy. They made significant developments within the past 10 years that has significantly lowered logistics costs and improved efficiency. He mentioned that China's logistics industry will focus on 1) promoting the organisation of logistics to evolve toward the organisation of the supply chain; 2) promoting the digital development of logistics; 3) promoting the green, low-carbon and sustainable development of logistics and supply chains; 4) enhancing the resilience and security of logistics and supply chains; and 5) integrating into globalisation and continuously improving the global governance system of logistics and supply chains.

Mr. Dakila Carlo Cua highlighted the significance of economic cooperation.

“As local governments assume their roles in the fulfilment of Philippine commitments to economic and trade agreements in various international and regional groupings such as ASEAN or the Asia-Pacific Economic Cooperation (APEC), we have witnessed the emergence of more dynamic, aggressive and entrepreneurial local governments, which are indispensable to any trade facilitation strategy.”

Mr. Dakila Carlo Cua, President of Union of Local Authorities of the Philippines (ULAP) and Governor of Quirino Province, shared how the economic cooperation between the provincial government and the Korea International Cooperation Agency helped reduce poverty incidence and restored major watersheds in five villages. He also mentioned how e-commerce, with the promising blend of traditional products and modern technology, is driving economic growth and innovation in Quirino Province.



Mr. Luo Zupan emphasised the importance of enhancing international logistics.

“We will move faster to make our brands and delivery services go global, build more branches in foreign markets, fulfilment centers, and exhibition halls to connect Yiwu with the world.”

Mr. Luo Zupan, Vice Mayor of Yiwu, described the Yiwu-Xinjiang-Europe freight train service, which boosted economic and trade ties, created jobs, and promoted economic development along its route, as a successful case of inclusive and win-win-cooperation. To strengthen international logistics, in addition to the establishment of the UCLG ASPAC Logistics Committee, Yiwu will make efforts towards building three Silk Roads: on land, maritime, and in air.

“Localism is at the heart of Local Government New Zealand (LGNZ).”

Mr. Sam Broughton, Co-President of UCLG ASPAC and Mayor of Selwyn District, stated how the Pacific Territorial Authority initiative of LGNZ was conceptualised to improve the people's quality of life in the Pacific Islands and the Mayors Taskforce for Jobs (MTFJ) Community Employment Programme (CEP) promoted community-led solutions for youth employment, education, and training. He underscored the importance of tailor-made solutions based from the approach that one size does not fit all.



Mr. Sam Broughton discussed the concept of Localism.

“To balance a city's economic growth with the sustainable development of its environment, it is necessary to have a scientific understanding of the relation between development and protection.”

Mr. An Enfa, Member of Standing Committee of CPC Kunming Municipal Committee and Vice Mayor of Kunming Municipal People's Government, illustrated Kunming's location and transportation advantages that allows it to connect with neighbouring countries and deepen cooperation. He cited the restoration of Dianchi Lake as an example of balancing economic growth with sustainable development of the environment.

“Where there are jobs, people will gather. However, the city's appeal is what makes them stay.”

Mr. Nakano Yusuke, Mayor of Hamamatsu City, remarked that to create a vibrant city, it is essential to focus on the development of jobs and the people. He also mentioned the Hamamatsu City International Strategy Plan which puts emphasis in fostering mutually beneficial cooperative relationships as a core pillar of diplomatic policy.



Mr. Nakano Yusuke discussed the importance of mutually beneficial cooperative relationships.

“We align with the Sustainable Development Goals (SDGs) to create a city that offers infrastructure and provides an excellent work environment to foster economic growth.”

Datuk Abd. Hamid Bin Hussain, President of Sepang Municipal Council, disclosed how public-private partnerships can support the implementation of the SDGs. They have several initiatives to make Sepang investor-friendly such as providing more spaces and opportunities for commercial and industrial activities and fast-tracking the approval process of development proposals.

The sub-forum highlighted that development of technologies can support global targets on reduction of carbon footprint. These include the development of photovoltaic industry, electronic vehicles, and light-emitting diode (LED). Policies and investment on renewable energy were also encouraged.

Speakers from local governments discussed their initiatives that addressed the needs of children in relation to education and public space. Speakers from the academic institutions presented insights in constructing public spaces that are child friendly.

Speakers from local governments highlighted the potential of rural areas and importance of natural resources to the livelihood of communities. They also underscored the role of infrastructure and integration of urban and rural areas in enhancing connectivity and supporting economic activities. Speakers from academic institutions discussed the value of transforming cultural and natural resources into economic resources and the need to bolster the rural entrepreneurial ecosystem.

Committee Meeting: Culture Committee

Jeju Special Self-Governing Province, as the Chair of the UCLG ASPAC Culture Committee, implemented several cultural policies and conducted three key activities in 2023. The International Workshop on Cultural Policy was held last 31 July to 4 August 2023 that gathered 30 people from 11 countries. The Jeju-Singapore Art Exchange Concert was held last 3 November 2023. The Global Young Creatives Residency Programme was held last 14-20 September 2023 and was participated in by 24 young artists and 38 lecturers. Jeju expressed commitment to continue their contribution to the cultural development in the Asia-Pacific region.

Three cities shared their cultural activities. Yiwu discussed about the China Yiwu Cultural Products Trade Fair, cultural heritage, and cuisine. Dagupan highlighted their Bangus Festival which celebrated the bountiful harvest as blessings from the sea and reminded the connection between the people and the sea. Pariaman shared about the Tabuik Festival, an important marker of identity in West Sumatra that boosts tourism, provides a positive image, and encourages social cohesion.



Committee Meeting: Humanitarian, Development and Peace (HDP) Nexus Committee

The HDP Nexus Committee, led by the Gyeonggi Provincial Government, emphasised that the global goals cannot be achieved without peace. Building peaceful societies is fundamental to sustained economic growth as a first step to fostering economic stability and social cohesion. The Committee noted that poverty alleviation and sustainable growth, two pillars of development cooperation, can serve as good basis for peace building. Peace building is necessary for the post-conflict social and political stability and prevention of further violent conflicts which would lead to aggravating humanitarian crises.





Committee Meeting: **South and Southwest Asia Standing Committee and** **Circular Economy Committee**

The South and Southwest Asia Standing Committee, as a sub-regional committee, was formed to strengthen cooperation among members and partners. Local government associations reported on their priorities and activities. Association for Development of Local Governance (ADLG) stated their advocacy towards decentralisation and empowerment of local governments. Federation of Sri Lanka Government Authorities (FSLGA) reported that they are implementing activities for the promotion of women leadership and youth engagement. Municipal Association of Nepal (MuAN) conducted capacity building activities for municipalities. National Association of Rural Municipalities in Nepal (NARMIN) demonstrated their advocacy initiatives with federal and provincial governments to provide budget and capacity building for local governments. All India Institute of Local Self-Government (AIILSG) emphasised the need to prioritise addressing the impacts of climate change and preparing for disasters. Municipal Association of Bangladesh (MAB) indicated that they are working for nationwide advocacy towards women-friendly Water, Sanitation and Hygiene (WASH) facilities.

For the Circular Economy Committee, AIILSG and MuAN mentioned that they are working together to finalise the action plan and review the activities of the committee. They plan to develop e-booklets on demystifying circular economy.



Committee Meeting: Southeast Asia Standing Committee

Through the Southeast Asia Standing Committee, a dynamic collaboration and active participation from the government, community-driven organisations, has been more accessible, enhancing Southeast Asia's development. The ASEAN Mayors Forum (AMF) is the flagship initiative of the Committee. To date, AMF has produced seven (7) declarations (2011-2023) that contribute to the decision-making processes within ASEAN and serve as guidelines for actions at the local level.

Lao PDR is the ASEAN Chair in 2024. They identified the theme “ASEAN: Enhancing connectivity” with Three Community Pillars on promoting infrastructure connectivity, narrowing the development gap, and promoting greater economic integration and people-to-people exchanges.

Issues raised during the meeting include: gradual and fragile recovery of the ASEAN region from multidimensional disruptions; climate change, natural disasters, and security issues as pressing challenges; need to have a local government unit (LGU) in the ASEAN Secretariat; and the pending collection of best practices. Solutions shared during the meeting include: enhancing connectivity and resilience in the region; increasing capacity development aligned with the AMF Declarations; increasing local government participation in regional advocacy; developing a Best Practices Collection Report of ASEAN Cities; strengthening collaboration among local governments in ASEAN and the Asia-Pacific region; and continuing efforts to localise the sustainable development goals (SDGs).



Committee Meeting: Standing Committee of Women in Local Governments

As chair of the Committee, Guangzhou organized a series of telemedicine webinar in 2022. These webinars enabled sharing of experiences and best practices in women and children healthcare. Other activities conducted by the Committee were the Orientation Workshop on Gender Responsive and Participatory Budgeting, and Meeting with Réseau des Femmes Elues Locales d'Afrique or the Network of Local Elected Women of Africa (REFELA). Mayors of Dhulikhel Municipality, Kageshwori Manohara Municipality and Dagupan City, and representative from NARMIN also shared their initiatives and insights on women empowerment.

As part of its work plan, the Committee reported that they are working with partners, the Federation of Canadian Municipalities (FCM), Penang Women's Development Corporation (PWDC), and UN-Habitat, in developing a customised module on Gender Responsive and Participatory Budgeting for local governments in the Asia-Pacific Region. The Committee is also representing the Asia-Pacific region in the UCLG Standing Committee on Gender Equality through Vice Chair of CPPCC Guangzhou Committee Madam Zhang Yajie, Catbalogan Councilor Ms. Stephany Uy-Tan and Mayor of Klang Ms. Noraini Roslan. The Committee stated that they will continue its coordination with REFELA and FCM to strengthen the network of women leaders in the region. On the nomination of co-chairs for the Committee, there was interest from Kageshwori Manohara Municipality for the South & Southwest sub-region.



Committee Meeting: Tourism Committee

The UCLG ASPAC Tourism Committee (UATC), led by the Xi'an Municipal People's Government, addressed several matters during their meeting. Progress has been made in expanding the number of member cities and followers on social media. Xi'an also reported on the establishment of the International Ancient City Wall and Castles Alliance under the Committee. Member cities such as Catbalogan and Phnom Penh reported on the status of the local tourism sector. New members were approved including Qingdao, Samarinda, Yogyakarta, and Yulin. The Committee's work plan for 2024 was also presented including the 3rd Batch of the Chinese Language Programme, art exhibition, International Forum on Culture and Tourism Development of Silk Road Cities, set-up of UATC display area at UCLG ASPAC Secretariat, change of UATC website server, and publication of UATC newsletter.

Summary:

UCLG ASPAC, with support from Bill and Melinda Gates Foundation (BMGF), has been implementing the Municipalities Network Advocacy on Sanitation in South Asia (MuNASS) project to address SDG 6.2 since 2018. Through this session, MuNASS introduced innovations and new technologies for safe sanitation. The application and benefits of Reinvented Toilets (RTs) in the improvement of the urban living environment was presented. RTs are effective for controlling pollution and achieving waste-to-resource conversion. Various low-cost toilet systems such as flush toilet for black water treatment system, waterless toilet, and box toilet were also introduced.

Summary:

Participants from UCLG ASPAC member countries, including Sri Lanka, Cambodia, Malaysia, Indonesia, Nepal, Pakistan, India, and the Philippines, gathered to champion the cause of empowering women in local governance. The event's dual objectives were clear: promote gender equality and encourage commitments from local governments and stakeholders to support and elevate women's participation and leadership. UCLG ASPAC members shared their commendable initiatives through posters, reflecting the progress made in their respective regions. Notable examples included Catbalogan's commitment to women's representation in local councils, Makati's establishment of the Gender and Development Council, and the All India Institute of Local Self-Government's Girl Power Project.

Summary:

The Urban-ACT project co-organised this learning forum in collaboration with GIZ China. The learning forum aimed to present the City Enabling Environment-Environmental and Climate Change Governance (CEE-ECG) assessment results and share the practices of pilot cities. The discussion on the CEE-ECG assessment results noted the need for core actions at the national level and for capacity building, and difference in national and local priorities. Practices shared by pilot cities include low-carbon transport, eco-village planning, waste management, and climate-sensitive spatial planning.

Summary:

This learning forum underscored that adaptability and diversification are at the core of economic growth strategies. A global mindset is important to thrive not only in cross-border e-commerce activities but in an increasingly interconnected world. Seamless operation through a streamlined process, technology application, and a robust distribution network are indispensable to logistics excellence. Collaboration among stakeholders was also raised as a crucial element in building a resilient logistic system, taking into consideration perspectives from business, transport, and environment sectors.



LAUNCH OF THE LOGISTICS COMMITTEE

Initiated by the Yiwu Municipal People's Government, the UCLG ASPAC Logistics Committee was launched. The Committee aims to promote logistics interconnectivity among member cities in the Asia-Pacific region, help them build logistics networks, and advance common economic development in the Asia-Pacific region. Specifically, the committee will:

1. Build a platform for dialogues, exchanges, experience sharing, mutual benefits and win-win outcomes, hold conferences, forums, and activities on logistics, and facilitate pragmatic logistics cooperation among members;
2. Conduct theoretical research and policy consultation on global logistics, and promote best practices and cases of urban logistics development;
3. Establish a logistics cooperation mechanism among member cities on a mutually beneficial basis, in a bid to promote resource-sharing and win-win outcomes in the region;
4. Develop special logistics routes between member cities; improve logistics accessibility to build a new connectivity pattern in the Asia-Pacific region; and
5. Promote the concept, technology, and application of sustainable development of urban logistics.

Mr. Ye Bangrui, Mayor of Yiwu, talked about Yiwu's three hallmarks as a transport hub, as a transport corridor with four dimensions (land, marine, cyber, and air routes), and its global distribution network. With the establishment of the UCLG ASPAC Logistics Committee, he suggested building a new platform for economic and trade cooperation and a new logistics network, advancing research and development and using new technologies for digital and intelligent logistics, developing new rules of customs clearance logistics, and advocating a new model of green logistics in the Asia-Pacific region.

Ms. Yang Xiao, Executive Vice President of China Communications and Transportation Association Urban Logistics Union and Chief Editor of China Logistics Times, explained how the global trade landscape is changing and how this led to the ongoing transition from cost-based competition and expansion to value-based competition in the logistics industry. She expressed commitment to contribute proposals to the UCLG ASPAC Logistics Committee to improve its global competitiveness.

EXPLORE YIWU



Blue Route



The Blue Route provided a glimpse of China's logistics and delivery systems. The route covered two key locations: Yiwu International Port and ZTO Express Company. At the Yiwu International Port, the China-Europe Railway Express was highlighted as environment-friendly and a preferred choice for many businesses being a faster and more economical alternative to traditional air or sea freight. The extensive delivery network of ZTO Express Company was shown to have propelled the growth of online shopping in China.



Colourful Route

The Colourful Route covered a variety of destinations: the world's largest wholesale market for small commodities (Yiwu International Trade Market), the departure station of the world's longest freight railway (Yiwu-Xinjiang-Europe freight railway), the birthplace of the first Chinese edition of The Communist Manifesto, the beautiful Gangyao Village known for its pottery culture, and leading photovoltaic companies. This enabled participants to understand and experience Yiwu's trade and culture.



Golden Route

The Golden Route introduced the International Trade Centre District and explained the opportunities to do business with Yiwu. The route covered two key locations: District 1 which had souvenir and craft shops and District 6 which featured the MU Group that engaged in export trade and cross-border e-commerce. The MU Group has operations in domestic branch offices and purchasing and sales branch office in multiple international cities. The participants learned valuable insights on the business and trade landscape in Yiwu.



Green Route

The Green Route helped the participants better grasp the experience of rural development as one of the core strategic elements of China's development and discover the realities of human coexistence and coordinated development between urban and rural areas. In this route, participants visited two villages. The Gangyaou Village is a national AAA-level scenic spot and a traditional Chinese village. The village had a vibrant ceramic culture and was home to a 1,000-year-old kiln built during the Northern Song Dynasty. The Xilou Village is considered China's First Village of Brown Sugar as locals thrived on growing sugarcane and producing sugar. Participants witnessed pollution-free brown sugar production base and enjoyed local sugar products.

Opening Ceremony of UCLG ASPAC Public Space (Friendship Garden)



Yiwu City inaugurated its first outdoor international friendship exchange space - Friendship Garden. The goal is to provide a place for international friends to strengthen their bonds. Situated in Yiwu Botanical Garden, the Friendship Garden is centred around the picturesque Lianyan Lake, featuring scenic attractions like the Jianbo Bridge, Youyi Pavilion, and the Friendship Woods. During the inauguration of the Friendship Garden, attendees collectively planted red plum trees, symbolising the unity of member cities and their shared vision for a brighter future in the Asia-Pacific region.



Trade And Business Matchmaking



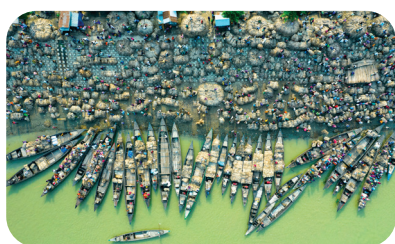

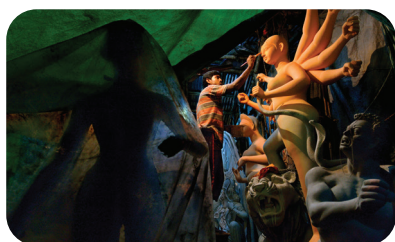
