# **Background**

As a part of the 10<sup>th</sup> UCLG ASPAC Congress co-hosted by Goyang Special City, Republic of Korea, a Photo Competition will be held to: (i) promote the event, (ii) provide visual representation of urban sustainability; (iii) highlight local governance and community engagement; (iv) promote cultural and regional diversity; and (v) spark inspiration for future urban solutions. The competition is open to the publics and the participants are to submit their photos virtually/online. There will be five (5) categories in line with the theme and sub-themes of the Congress. A board of jury will review the open call submissions and select the winner for every category.

UCLG ASPAC invites publics to join the Photo Competition. Winners will be announced during the 10<sup>th</sup> UCLG ASPAC Congress in 24-26 September 2025.


# **Application / Submission Requirements**

- All photos must be submitted via <u>submission</u> form no later than Friday, 8 August 2025 at 23.59 PM (Jakarta Time/GMT+7).
- Each participant may submit a max of 3 (three) photos only.
- UCLG ASPAC staff members are restricted to participate in the competition
- Please provide the **description of each photo** (Max. 100 words/photo).
- Please enclose a **Short Bio** (Max. 450 words). This will not be provided to the Board of Jury.
- Photo description and participant bio must be in **English**.

Each winner will receive **500 USD**(Taxes included) and certificate.




# **THEME**

The main theme of the 10<sup>th</sup> UCLG ASPAC Congress is


Sustainable Global Self-sufficient Cities and Regions for the Future

The photo competition will have five (5) categories with 1 (one) winner for every category following the sub-themes.



# **Job Creation**

Job creation is a critical component of building self-sufficient cities. A city's self-sufficiency isn't just about environmental sustainability—it also includes economic resilience. Sustainable cities need to offer opportunities for green jobs and employment in sectors like renewable energy, waste management, eco-tourism, and sustainable agriculture. This category seeks photos depicting the process of job creation (from grassroots level to the strategies of economic development), work opportunities, and innovative projects that contribute to job creation in sustainable urban environments. This could include images of local markets, eco-friendly businesses, green job initiatives (such as renewable energy or sustainable agriculture), and community-led enterprises that create economic opportunities for the local population.







Theme 5

# **Urban Growth**

Urban growth needs to be managed sustainably to ensure that cities don't become overburdened by population increases. Sustainable urban growth involves smart growth strategies, urban planning that prioritizes green spaces, sustainable infrastructure, and resilience to climate change. This category seeks photos capturing sustainable urban development in the face of growing populations. This could include images of smart city solutions, green buildings, urban planning that integrates nature (like green roofs or vertical gardens), and how cities manage their growth while keeping sustainability in mind.



### **Photos Criteria**

The applying participant declares and undertakes to verify that the submitted photo/s correspond to the stipulations of the Photo Competition rules and regulations, and meet the following criteria:

- All photographs submitted must be original works by the applying participant.
- No restriction of using any device for photography.
- If the submitted images include minors, or models/subjects incapable of explicitly consenting to being photographed, the applying participant may be required to provide a written consent of the subject's parents/custodians to use the image, according to circumstances.
- The photo/s must be free of any binding agreement with a third party that might hold UCLG ASPAC liable for payment to any individual or entity in connection with the images' copyright or their use.
- The submitted photo/s must not contain any symbol that represent any sensitive political issues.
- The photo/s should be in high quality (Min. 10 MB), to be submitted in JPG format.

# **Rules and Regulations**

- The photo/s must be original, created, and/or taken by the participant.
- No restriction of using any device for photography
- The submitted photo/s must be free of any binding agreement with a third party that might hold UCLG ASPAC liable for payment to any individual or entity in connection with the images' copyright or their use.
- If the submitted images include minors, or models/subjects incapable of explicitly consenting to being photographed, the applying participant may be required to provide a written consent of the subject's parents/custodians to use the image, according to circumstances.
- The submitted photo/s must not contain any symbol that represent any sensitive political issues.
- The applying participants accept the stipulations of the Event rules and regulations wholly and absolutely.
- UCLG ASPAC reserves the right to review the suitability of the participants to the criteria and to rule in any dispute that may arise at any time on this issue.

### **Relevant Dates**

- Application opens on **Wednesday**, **7 May 2025** and closes at 23.59 on **Friday**, **8 May 2025**, Jakarta time (GMT +7).
- Applying participants are responsible for determining the start and closing time of the competition in their time zone (insofar as they are outside Jakarta, Indonesia).
- The winner of every category will be announced during the 10<sup>th</sup> UCLG ASPAC Congress on **Wednesday-Friday**, **24-26 September 2025**.
- UCLG ASPAC reserves the right to change these dates, and to publish the new dates on the UCLG ASPAC's website and/or social media.

### **General Comments**

- By participating in the Photo Competition, the participants accept de facto all the rules and regulation clauses.
- UCLG ASPAC reserves the right to change the listed dates and/or the jury members at its discretion.
- The decision of the board of jury is final and irrevocable.
- Choice of law, jurisdiction, arbitration: The clauses of these rules and regulations are subject to and interpreted under the Indonesia Law. Should any of the listed stipulations be canceled or declared impossible to enforce, all the other stipulations will remain unchanged and valid.

# **Intellectual Property Rights**

- The participant applying for the Photo Competition will maintain ownership rights of all the intellectual property (including ethical rights) related to the photo/s, subject to the rules and regulations.

# International Essay Competition for Youth and Journalists

Sustainable Global Self-sufficient Cities and Regions for the Future



### **About**

Our world is facing unprecedented challenges. According to the United Nations (UN), more than half of the global population now resides in urban areas, and by 2050, this number is expected to rise to 68% (UN, 2018). This rapid urbanization places immense pressure on cities and regions, increasing demands for infrastructure, housing, employment, and resources. Concurrently, cities contribute significantly to global CO2 emissions, which continue to rise as climate change exacerbates the challenges facing urban centers. According to the Intergovernmental Panel on Climate Change (IPCC), cities account for more than 70% of global energy consumption and CO2 emissions, making them pivotal to both the crisis and its solution (IPCC, 2022), and as a result, are on the frontlines of both the impacts and solutions to this crisis.

Simultaneously, the global economy is shifting, and with it, we are witnessing rising inequality, youth unemployment, and the need for more inclusive and equitable cities. Research from the International Labour Organization (ILO) highlights that global youth unemployment rates are dangerously high, limiting economic mobility and opportunity for younger generations (ILO, 2024). These realities underscore the urgent need for action, particularly at the local level, where governance can directly affect people's lives.

As the world faces these challenges, The 10<sup>th</sup> UCLG ASPAC Congress offers an unparalleled opportunity to explore how to create self-sufficient, sustainable cities and resilient regions that will thrive in the future. With the theme, "Sustainable Global Self-Sufficient Cities and Regions for the Future," the congress will not only to just discuss about change—but also to drive it.

In this regard, as part of the 10<sup>th</sup> UCLG ASPAC Congress in Goyang Special City, Republic of Korea, an International Essay Competition will be held to promote the event, encourage the thinking of self-reliant and self-sufficient communities, exchange knowledge and insights, while also spark inspiration for future urban solutions.

# **Main Theme**

This essay competition is an activity within the 10<sup>th</sup> UCLG ASPAC Congress in Goyang Special City, Republic of Korea and adopts the main theme of **Sustainable Global Self-sufficient Cities and Regions for the Future.** 

# Sub-Topic

Essays will be written under the main theme of Sustainable Global Self-sufficient Cities and Regions for the Future and essayists can choose to elaborate on the 5 sub-topics such as:











# **Categories of Essay Competition**

The competition is open to 2 (two) categories of essayist:

# Youth

from all nationalities aged 15-25

# Journalist

Accredited/professional journalists internationally

**Awards** The following awards will be given in the Youth's category and Journalist's category respectively:

- A prize of USD 500, USD 300, USD 200 for the first, second, and third winner in the Youth category.
- A prize of USD 750, USD 400, USD 250 for the first, second, and third winner in the Journalists category.

Winners from the Youth and Journalists category will be invited to the Winners Gathering during the 10<sup>th</sup> UCLG ASPAC Congress Meeting to be held online

### **Terms and Conditions**

- 1. Essays may be submitted by anyone up to 25 years old (as of September 26, 2025) for the **Youth Category**.
- 2. There is no minimum age requirement for the Journalists Category. However, only journalists accredited by their Press Card could join the essay competition.
- 3. Entrants can only choose **one** of the five themes mentioned above.
- 4. Essays must be original/originally written by the entrant. Therefore, all sources must be cited and referred to the respective part in the essay as all entries will be tested for plagiarism.
- 5. Only **one** essay entry is allowed.
- 6. Essays must be unpublished.
- 7. Contents of the essay **must adhere** to the **'One** China Policy' (no mention of Taiwan), and most not contain or represent any sensitive political issues.
- 8. If you have any questions, please refer to the FAQs section.

# Application and Submission Requirements

Essays must be max. 1000 words in English. Essays must be typed, with your name, institution (such as university, if entrants are still attending university), chosen theme and essay title included at the top of the first page.

There are no rules regarding formatting (font style, size, line space, etc.). However, essays must be submitted in either MS Word (DOC/DOCX) or PDF format.

\*Note: Your name and essay title are not included in the word count limit.

Your essay entries must be submitted via <u>submission form</u> no later than Friday, 8<sup>th</sup> August 2025 at 23:59 PM (Jakarta Time/GMT+7).

For journalists submitting their essay, please also attach a file of your Press Card.



# **Intellectual Property Rights**

By submitting your essay, you give permission to the organiser to publish it in any medium (such as the UCLG ASPAC website). Ownership of the essay remains with the entrant and will be visible.

# **Frequently Asked Question (FAQ)**

Q1 - Are there any exceptions to the age limit for participating in the contest?

A1 - No, you must be 25 years old or younger as of September 26, 2025, which is the last day of 10<sup>th</sup> UCLG ASPAC Congress. On the other hand, for Journalists Category there is no minimum age requirement.

# Q2 - Is there a fee for participating in this contest?

A2 - No, participation is free of charge.

# Q3 - Do I have to be citizens of Asia or Pacific countries to join the contest?

A3 - No, all nationalities can participate from anywhere in the world.

# Q4 - My essay is a little over 1000 words. Is it acceptable?

A4 - No, essay must be max. 1000 words to qualify. However, your name and essay title are excluded from the word count.

# Q5 - Are my name and essay title included in the word count limit?

A5 - No, the 1000-word count limit is for the body of the essay only.

# Q6 - Do I need a cover page for my essay?

A6 - No, a cover page is not required. Please just include your name and essay title at the top of the first page of your essay.

# Q7 - Can I give any title to my essay?

A7 - Yes, you can give your essay an original title as long as the content is in line with the theme.

# Q8 - Is there a specific format for the essay (font style, size, line space, etc.)?

A8 - There are no particular rules regarding formatting. However, your essay file should be in either MS Word (DOC/DOCX) or PDF format.

# Q9 - Is there a specific style for the essay?

A9 - No. Essays may be in any style (thesis or prose, academic or literary), as long as the content is in line with the theme.

# **Frequently Asked Question (FAQ)**

Q10 - Can I quote from books or websites? If so, where should I write the reference?

A10 - If you use quotations, please include the reference at the bottom of the essay. The reference should not be included in the word count.

Q11 - Can I add photos, images, or my biography to my essay?

A11 - No. Please send your essay only.

# Q12 - Can I submit my essay via postal mail?

A12 - No, we do not accept entries by postal mail. Please submit your essay to the **submission form** 

# Q13 - Can I submit a hand-written essay?

A13 - No. Please submit a typed essay in either MS Word (DOC/DOCX) or PDF format.

# Q14 - Can I submit more than one essay?

A14 - No, only one entry per person is accepted.

Q15 - Can I submit my essay in my native language?

A15 - Essays are accepted in English only.

# Q16 - Can we co-write and submit one essay as a team?

A16 - No. The essay must be written by one person. Co-authored essay are not accepted.

Q17 - I did not receive a confirmation email after submitting my essay. How can I make sure that my essay has been successfully submitted and received?


A17 - You will not receive a confirmation email after submitting your essay.

# Introduction

Its members – representing local governments and their associations across Asia-Pacific – have set a high priority on implementing and achieving the Sustainable Development Goals (SDGs) by 2030 and have been working with partners from around the world to accelerate their localisation. UCLG ASPAC also serves as the knowledge management hub for local government issues in the Asia-Pacific region, promoting democratic local self-government and fostering cooperation among governments and international communities.

In alignment with this mission, and as part of the 10<sup>th</sup> UCLG ASPAC Congress co-hosted by Goyang Special City, UCLG ASPAC is proud to launch the Startup Pitching Competition — a dynamic platform to spotlight startups that are transforming urban futures through innovation. This competition invites early-stage and growth-stage startups whose solutions contribute to building more sustainable, inclusive, and self-sufficient cities and regions.

By connecting innovation ecosystems with city leaders, this initiative aims to accelerate the adoption of creative solutions that address real-world local challenges — from public service innovation and green infrastructure to civic tech and social inclusion.

Selected finalists will be given the opportunity to pitch live during the Congress, engage with local government representatives, receive international exposure through UCLG ASPAC's networks, and compete for funding, and collaboration opportunities. This competition also supports the broader goal of embedding youth innovation and entrepreneurial thinking into local policy spaces and governance systems.

### Theme

# Innovating Local Futures: Startups for Resilient, Inclusive, and Self-sufficient Cities and Regions

In support of the 10<sup>th</sup> UCLG ASPAC Congress' overarching theme — "Sustainable Global Self-sufficient Cities and Regions for the Future" — the Startup Pitching Competition centres on the role of innovation and entrepreneurship in shaping the next generation of urban solutions.

# Startups are invited to submit ideas and solutions that address one or more of the following key areas:

# **Smart and Digital Governance**

Innovative solutions that improve public service delivery, citizen engagement, and government transparency through digital tools, platforms, or data systems.

# **Urban Climate Resilience and Adaptation**

Startups addressing climate risks in urban areas, including flood mitigation, early warning systems, green infrastructure, and nature-based solutions.

# **Circular Economy and Sustainable Infrastructure**

Solutions that reduce waste, promote reuse and recycling, and design infrastructure with long-term environmental and economic sustainability in mind.

# **Inclusive Public Services and Community Participation**

Ideas that ensure access to essential services (health, education, housing, etc.) for all citizens, especially marginalised groups, while strengthening local participation.

# **Civic Tech and Youth-led Innovation**

Technology or digital solutions developed by or for youth that enhance civic engagement, local problem-solving, and urban innovation.

# **Energy Self-sufficiency and Green Solutions**

Startups focused on renewable energy, energy access, energy storage, or efficiency that reduce urban dependency on external sources.

# **Job Creation and Local Economic Resilience**

Initiatives that promote entrepreneurship, skill-building, and employment opportunities within local economies, especially in green and future-ready sectors.

# Family-friendly and Human-centred City Design

Innovations that make cities more liveable for families, such as accessible public spaces, childcare-friendly infrastructure, safe mobility, and community support systems.

### **Award Prize and Rewards**



**Cash Prizes** – Top performing startups will receive monetary awards as recognition for their innovation and impact.

- \$3,000 as 1st Prize
- \$1,500 as 2<sup>nd</sup> Prize

# **Eligibility**

- Startups, innovation teams, or early-stage ventures from the Asia-Pacific region.
- The team may be legally registered or in the process of formation, and must consist of 1 to 5 members.
- Preference will be given to youth-led teams (with at least one member under 35 years old).
- Only one application per team/startup is allowed.
- UCLG ASPAC staff members and their direct affiliates are not eligible to participate.

### **Language Requirements**

- All written content, videos, pitch decks, and posters must be submitted in English.
- Submissions in other languages will not be evaluated.

### **Submission Reminders**

- Ensure all file uploads are complete and all links are working before the deadline.
- Do not submit materials that are password-protected or require login access.
- Maintain original filenames or use the provided naming format for easier identification.

A short background description of your team, highlighting your motivation, relevant experience, and vision for the future. This will not be provided to the jury but may be used for promotional and networking purposes during the Congress. Include in the form as a text input or document upload (if required)

The following seven (7) criteria will be used to determine the overall score of each submission.

- Relevance to Urban and Local Challenges
- Innovation and Originality
- Feasibility and Practicality
- Impact and Sustainability
- Scalability and Replicability
- Presentation and Storytelling
- Public Engagement (Social Media Voting)

### **Rules & Regulations**

- All submitted ideas, materials, and content (including the video, pitch deck, and poster) must be original, created and/or developed by the applying participant or team.
- There is no restriction on tools or platforms used to create the pitch materials (e.g. camera type, editing software, pitch design tools).
- Submitted content must be free from any binding agreement with a third party that might hold UCLG ASPAC liable for compensation or copyright disputes.
- If submitted materials include identifiable individuals (e.g. in videos or images), especially minors or those unable to legally consent, participants may be required to provide a signed consent from the individuals or their guardians.
- Submitted materials must not contain content, symbols, or narratives that represent or promote any form of sensitive political issues, hate speech, or discriminatory messaging.
- The applying participants are considered to have fully accepted the terms and conditions of the event by submitting their entry.
- UCLG ASPAC reserves the right to assess the eligibility of each submission and participant, and to resolve any disputes that may arise regarding compliance, scoring, or result announcement at its sole discretion.
