A. BACKGROUND / INTRODUCTION

The *City Enabling Environment on Environmental and Climate Governance (CEE-ECG)* assessment was developed in 2024 with support from **Urban-Act Project – Integrated Urban Climate Action for Low-Carbon and Resilient Cities**, funded by the German Federal Ministry for Economic Affairs and Climate Action (BMWK) through the **International Climate Initiative (IKI)**. Implemented by **GIZ** in partnership with **UCLG ASPAC**, **UNESCAP**, **TU Dortmund University**, and the **University of Stuttgart**, the project aims to strengthen enabling conditions for local climate action and resilient urban governance across Asia and the Pacific. Within this framework, the CEE-ECG was delivered as part of **Work Package REG I.1 (Comparative Research and Analysis)**, providing a comprehensive regional assessment of policy, institutional, and operational enablers for environmental and climate governance in five Urban-Act countries: China, India, Indonesia, the Philippines, and Thailand.

Following the completion of the CEE-ECG 2024 baseline assessment, **CEE-ECG Phase II (2025–2026)** will advance the process from research and analysis toward **advocacy, monitoring, evaluation, and updating**. This continuation bridges the findings of Work Package REG I.1 with ongoing advocacy and regional policy engagement under the Urban-Act Project. It ensures that the evidence and recommendations derived from the

CEE-ECG are translated into concrete action, sustained dialogue, and policy refinement at both national and regional levels.

To achieve this, two complementary consultancies are established under this ToR. At the **national level**, the *CEE-ECG India Consultation on Advocacy, Implementation and Policy Uptake* will coordinate closely with **GIZ India, AIILSG, and UCLG ASPAC** to apply CEE-ECG results within India's evolving policy landscape. The consultant will facilitate advocacy, implementation, and contextual updating activities while producing policy recommendations and briefs to inform national and subnational governments.

At the **regional level**, the *CEE-ECG Regional Consultation on Monitoring, Evaluation and Updating Process* will lead cross-country coordination among the five Urban-Act countries, ensuring consistency in methodology and alignment between local implementation and regional frameworks. This consultancy will conduct monitoring and evaluation, refine indicators, and prepare regional policy briefs and recommendations to inform intergovernmental and multilateral dialogues.

The consultancies strengthen UCLG ASPAC's role within the Urban-Act consortium as the regional actor linking **research (WP REG I.1)** with **advocacy and policy processes (WP REG II.2)**. The updated CEE-ECG results and policy recommendations will feed directly into regional advocacy platforms, culminating in their presentation at the 2026 UNESCAP Meetings and the ASEAN Governors and Mayors Forum (AGMF) 2026 in Manila — marking the transition from comparative assessment to applied policy influence under the Urban-Act Project.

B. Objectives

The overall objective of the *CEE-ECG Phase II Consultancy on Advocacy, Monitoring and Updating Process* is to strengthen the application, policy uptake, and continuous improvement of the *City Enabling Environment on Environmental and Climate Governance (CEE-ECG)* results under **Work Package REG I.1 – Comparative Research and Analysis of the Urban-Act Project**.

This phase ensures that the findings from the 2024 CEE-ECG assessment evolve into actionable strategies, policy recommendations, and regional learning processes that reinforce Urban-Act's overarching mission to advance low-carbon, resilient, and well-governed cities in Asia and the Pacific.

Specifically, the consultancies aim to:

(1) CEE-ECG Consultation on Advocacy, Implementation and Policy Uptake in India

- Facilitate advocacy and implementation works based on the CEE-ECG recommendations, including learning exchanges and stakeholder consultations in collaboration GIZ India;
- Update the CEE-ECG assessment contextual analysis to reflect recent policy, governance, and institutional developments; and
- Develop policy briefs and recommendations to guide government action and support policy uptake at national and local levels.
- Coordinate with GIZ India, NIUA, AIILSG, and UCLG ASPAC to align CEE-ECG findings with India's national and subnational policy context;

(2) CEE-ECG Regional Consultation on Monitoring, Evaluation and Updating Process

- Lead the regional monitoring and evaluation based on the CEE-ECG baseline assessment result in 2024 across the five Urban-Act pilot countries (China, India, Indonesia, Thailand, and the Philippines);
- Coordinate with national consortium partner to ensure methodological consistency, data validation, and harmonised reporting;
- Refine the assessment framework and indicators to reflect updated enabling environment conditions;
- Develop regional advocacy materials, including comparative policy briefs and recommendations, to support intergovernmental dialogue; and
- Contribute to the preparation and presentation of the final updated results and policy recommendations during the 2026 UNESCAP meetings and the ASEAN Governors and Mayors Forum (AGMF) 2026 in Manila.

C. Scope of Work

To achieve the objectives described above, two (2) consultants will be engaged under the supervision of UCLG ASPAC's Urban-Act Project Team, in coordination with GIZ, AIILSG, and other Urban-Act Consortium partners. These consultancies form part of the continuation of Work Package REG I.1 (Comparative Research and Analysis), ensuring that the *City Enabling Environment on Environmental and Climate Governance (CEE-ECG)* results transition effectively from research to implementation, advocacy, and policy refinement under Work Package REG II.2.

(1) CEE-ECG India Consultation on Advocacy, Implementation and Policy Uptake

The consultant will support the advocacy, implementation, and contextual updating of the *CEE-ECG India* results to ensure their relevance and integration into national and subnational policy processes. The work will include:

a. Coordination and Planning

- Coordinate closely with GIZ India, AIILSG, and UCLG ASPAC to review CEE-ECG India findings and identify key areas for advocacy and policy dialogue.
- Prepare an inception report and work plan outlining methodology, timeline, deliverables, and coordination mechanisms.
- Participate in joint planning meetings with the Regional Consultant and the Urban-Act team to align the India process with the overall regional updating cycle.

b. Advocacy and Implementation Support

- Facilitate stakeholder consultations, advocacy meetings, and learning events to promote the implementation of CEE-ECG India recommendations among local governments and associations.
- Support the preparation of communication and advocacy materials showcasing enabling environment progress, best practices, and governance challenges.
- Assist in the coordination and implementation of advocacy actions and technical discussions in collaboration with national and local partners.

c. Updating and Contextual Analysis

- Review and update the *CEE-ECG India context* by analysing the relationship between assessment results and recent developments in governance and policy.

- Conduct analytical mapping linking updated data with CEE-ECG dimensions (institutional, operational, administrative).
- Coordinate with the Regional Consultant to integrate updated India findings into the regional CEE-ECG framework.

d. Policy Development and Reporting

- Develop an Initial Policy Brief or Recommendation to support early advocacy and implementation activities, drawing on the baseline CEE-ECG India results.
- Prepare an Advocacy and Implementation Activity Report summarising events, learning exchanges, and progress.
- Produce a Final Policy Recommendation or Brief reflecting the updated CEE-ECG India context and outcomes of advocacy and implementation efforts.
- Submit a Final Report consolidating all outputs, findings, and lessons learned for inclusion in the regional comparative process and AGMF 2026 presentation.

(2) CEE-ECG Regional Consultation on Monitoring, Evaluation and Updating Process

The consultant will lead the regional monitoring, evaluation, and updating process for the CEE-ECG across five Urban-Act countries (China, India, Indonesia, Thailand, and the Philippines), ensuring consistency of methodologies and alignment with Urban-Act's advocacy and policy objectives.

a. Framework and Methodological Development

- Develop a proposal and updated methodological framework for the next CEE-ECG assessment, including refined indicators and evaluation criteria.
- Formulate a regional monitoring and evaluation plan aligned with the Urban-Act M&E framework under Work Package REG I.1.
- Ensure methodological continuity and comparability with the 2024 assessment, integrating country-specific updates.

b. Coordination and Capacity Support

- Coordinate with CEE-ECG India and Indonesia consultants to ensure harmonised approaches for advocacy, implementation, and updating.
- Provide technical guidance and backstopping to national partners for data collection and reporting consistency.
- Facilitate coordination and review meetings with Urban-Act focal points and consortium partners.

c. Monitoring and Evaluation of Implementation

- Monitor progress of advocacy and implementation activities across the five countries.
- Evaluate effectiveness, challenges, and lessons emerging from the application of CEE-ECG recommendations.
- Produce interim and final M&E reports consolidating achievements, gaps, and lessons learned.

d. Policy and Knowledge Products

- Develop two key regional policy outputs:
 - i. Initial Comparative Policy Brief, based on 2024 results and initial advocacy experiences across the five countries; and

- ii. Final Regional Policy Recommendation, incorporating updated findings and validated outcomes from the 2025–2026 updating process.
- Produce additional regional knowledge materials (summary notes, comparative papers, or analytical insights) to support advocacy and learning.
- Assist UCLG ASPAC in preparing presentation materials for APFSD 2026, the 82nd ESCAP Commission in Baku, and AGMF 2026 in Manila.

e. Reporting and Coordination with Urban-Act Partners

- Prepare a Final Regional Report (Updated CEE-ECG Comparative Report) integrating data, analysis, and policy recommendations.
- Submit progress updates, datasets, and supporting documents to UCLG ASPAC and GIZ.
- Collaborate with TU Dortmund University, University of Stuttgart, and other consortium partners to ensure regional alignment and knowledge integration.

D. Deliverables

Both consultants are required to produce a series of deliverables that demonstrate the achievement of objectives under Work Package REG I.1, ensuring continuity from research to implementation, monitoring, and policy advocacy. Each consultant will deliver specific outputs aligned with their respective mandates — the India Consultant on national advocacy and policy uptake, and the Regional Consultant on regional monitoring, evaluation, and updating — as outlined below.

(1) CEE-ECG India Consultation on Advocacy, Implementation and Policy Uptake

The consultant shall deliver the following outputs:

- a. Inception and Planning
 - An Inception Report and Work Plan outlining objectives, scope, methodology, coordination mechanism, and timeline, validated by UCLG ASPAC, GIZ India, and AILSG.
- b. Advocacy and Implementation Activities
 - Documentation of Advocacy and Implementation Activities, including reports of meetings, workshops, and learning sessions conducted with Indian cities and local stakeholders.
 - Summary Notes or Learning Outputs from dialogues and peer-exchange sessions held during the advocacy phase.
- c. Analytical and Updating Outputs
 - An Updated CEE-ECG India Context Report analysing the linkage between CEE-ECG results and the current national/subnational policy and institutional setting.
 - Integration notes for regional coordination with the M&E consultant to ensure India's updates feed into the comparative framework.
- d. Policy and Knowledge Products
 - An Initial Policy Brief or Policy Recommendation, prepared early in the consultancy as the main advocacy instrument based on baseline CEE-ECG India results.
 - A Final Policy Recommendation or Policy Brief, incorporating findings from the updated context and advocacy implementation process, addressed to both national and local governments.

- A Final Advocacy and Implementation Report compiling all activities, key findings, progress, lessons learned, and recommendations for the regional presentation at AGMF 2026.

- Excellent communication, writing, and presentation skills in **English**; proficiency in **Hindi** or other Indian local languages is an asset.
